## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2007 – Prince George’s County**  
3 **– Historic Greenbelt Theater**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2007  
5 to provide that certain grants for the Historic Greenbelt Theater may not  
6 terminate before a certain date; and generally relating to amending the  
7 Maryland Consolidated Capital Bond Loan of 2007.

8 BY repealing and reenacting, with amendments,  
9 Chapter 488 of the Acts of the General Assembly of 2007  
10 Section 1(3) Item ZA01(AY) and Item ZA02(BN)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Chapter 488 of the Acts of 2007**

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
15 MARYLAND, That:

16 (3) ZA01 LOCAL HOUSE INITIATIVES

17 (AY) Historic Greenbelt Theater. Provide a grant equal to the  
18 lesser of (i) \$200,000 or (ii) the amount of the matching fund  
19 provided, to the Mayor and City Council of the City of  
20 Greenbelt for the construction, repair, renovation,  
21 reconstruction, and capital equipping of the Historic  
22 Greenbelt Theater, located in the City of Greenbelt, subject to  
23 a requirement that the grantee grant and convey a historic  
24 easement to the Maryland Historical Trust.
