A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2007 – Montgomery County –**
3 **Warren Historical Site – Loving Charity Hall**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2007
5 to provide that a certain grant for the Loving Charity Hall may not terminate
6 before a certain date; making a technical correction; and generally relating to
7 amending the Maryland Consolidated Capital Bond Loan of 2007.

8 BY repealing and reenacting, with amendments,
9 Chapter 488 of the Acts of the General Assembly of 2007, as amended by
10 Chapter 707 of the Acts of the General Assembly of 2009
11 Section 1(3) Item ZA01(AS)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That:

18 (3) ZA01 LOCAL HOUSE INITIATIVES

19 (AS) Warren Historical Site – Loving Charity Hall. Provide a grant
20 equal to the lesser of (i) \$175,000 or (ii) the amount of the
21 matching fund provided, to the Board of Directors of the
22 Warren Historic Site Committee, Inc. for the reconstruction,
23 repair, renovation, construction, and capital equipping of
24 Loving Charity Hall, located in Martinsburg, subject to a
25 requirement that the grantee grant and convey a historic

1 easement to the Maryland Historical Trust. Notwithstanding
 2 Section 1(5) of this [Acts] ACT, the matching fund may
 3 consist of real property, in kind contributions, or funds
 4 expended prior to the effective date of this Act.
 5 Notwithstanding Section 1(5) of this Act, the grantee has until
 6 June 1, 2011, to present evidence that a matching fund will be
 7 provided. **NOTWITHSTANDING SECTION 1(7) OF THIS ACT,**
 8 **THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1, 2016**
 9 (Montgomery County) 175,000

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 11 June 1, 2014.
