### FISCAL AND POLICY NOTE

House Bill 1390

(St. Mary's County Delegation)

**Environmental Matters** 

Education, Health, and Environmental Affairs

#### St. Mary's County - Public Officials - Salaries

This bill increases the salaries of certain public officials in St. Mary's County including the county treasurer, sheriff, orphans' court judges, and board of county commissioners, to take effect at the beginning of the next term of office.

### **Fiscal Summary**

**State Effect:** None.

**Local Effect:** St. Mary's County expenditures increase by \$16,500 in FY 2015 and by \$50,100 in FY 2019 for increased salary and benefits for county officials.

**Small Business Effect:** None.

## **Analysis**

**Bill Summary/Current Law:** Salary changes for public officials take effect at the beginning of the next term of office. In St. Mary's County, the term of office for county commissioners, the sheriff, treasurer, and orphans' court judges begins in January 2015. Proposed salary changes for St. Mary's County public officials are shown in **Exhibit 1**.

**Background:** The St. Mary's County Board of Commissioners consists of five members, including the president, who each serve four-year terms. St. Mary's County has three orphans' court judges.

**Local Fiscal Effect:** St. Mary's County expenditures would increase by \$33,100 in calendar year 2015 and by \$50,100 in calendar year 2018 for increased salary and benefits (at a rate of 25% as advised by the county) for county officials included in this bill. On a fiscal year basis, St. Mary's County expenditures increase by \$16,500 in

fiscal 2015 and by \$50,100 in fiscal 2019. **Exhibit 2** shows the breakdown of the increase in compensation for each position by fiscal year, and **Exhibit 3** shows the total compensation increase for all public officials included in the bill by fiscal year. This estimate assumes that the benefits rate remains constant at 25%.
