## 10. Description and Purpose of Grantee Organization (Limit Length to Visible area)

The Montgomery County BlackBox Theater Project will refurbish an existing theater space by renovating and replacing furniture, fixtures, and equipment in the current space. This will allow the Department of Recreation to develop a contract for service with an operator for multipurpose use of the space to provide an ongoing theater arts program of instruction and performances for all residents.

Additionally, the project will provide technical equipment and fixtures such as theater lighting & sound systems with digital capacity, backstage communications, building signage, etc. Since the building's construction in 2003, the County has initiated a program of significant ADA upgrades to all facilities. A portion of this grant will be utilized to effect ADA improvements throughout the facility. An inventory of necessary changes is currently being developed.
