House Bill 825

(Anne Arundel County Delegation)

Environmental Matters

Judicial Proceedings

Anne Arundel County - State's Attorney and Deputy, Assistant, and Temporary
Assistant State's Attorneys - Annual Salary and Compensation

This bill repeals the existing statutory provisions that govern the method by which the salary for the Anne Arundel County State's Attorney is set. Instead, the bill establishes that the salary is \$175,000 for calendar 2015 and subsequent years. The bill also specifies that the salaries of deputy State's Attorneys and assistant State's Attorneys, including temporary assistant State's Attorneys, are subject to approval by the county *council*.

Fiscal Summary

State Effect: None.

Local Effect: Salary expenditures increase by \$2,200 in FY 2015 and by \$1,900 in FY 2016. Beginning in FY 2017, salary expenditures decrease by at least \$3,200 annually; the savings increases over time. Revenues are not affected.

Small Business Effect: None.

Analysis

Current Law/Background: Chapter 168 of 2000 established that for calendar 2003, the salary of the State's Attorney in Anne Arundel County was to be equal to the salary of a circuit court judge as of December 31, 2002. In each calendar year thereafter, the salary increases by 3%. Accordingly, the calendar 2014 salary for the Anne Arundel State's Attorney is \$165,551, which reflects a 3% increase over the calendar 2013 salary of \$160,729. **Exhibit 1** shows the salary for the State's Attorney in each county based on fiscal 2014 data (where available), as provided by the Maryland Association of Counties.

Salaries for the two deputy State's Attorneys are subject to the approval of the county and may not exceed 90% of the State's Attorney's salary. Salaries for assistant State's Attorneys are subject to approval by the county and may not exceed 80% of the State's Attorney's salary. Subject to approval by the administrative judge of the circuit court, the

State’s Attorney may appoint a temporary assistant State’s Attorney for a particular case or series of cases. The State’s Attorney may set compensation for the temporary assistant State’s Attorney, subject to the approval of the county.

Senate Joint Resolution 3 of 2012 established the following salaries for circuit court judges: (1) \$144,908 in fiscal 2014; (2) 149,600 in fiscal 2015; and (3) \$154,433 in fiscal 2016. Until the salary increases established in 2012, judicial salaries had not increased since fiscal 2009.

Article III, § 35 of the Maryland Constitution prohibits the salary or compensation of any public officer from being increased or diminished during the individual’s term of office, except those whose full term is fixed by law in excess of four years.

Local Fiscal Effect: Salary expenditures increase by \$2,200 in fiscal 2015 and by \$1,900 in fiscal 2016. Beginning in fiscal 2017, salary expenditures decrease by at least \$3,200 annually. By fiscal 2019, salary expenditures decrease by \$14,100 annually. These estimates reflect the elimination of the statutory 3% salary increase, but do not include any minimal additional impact on fringe benefits. **Exhibit 2** illustrates the difference in the salary of the State’s Attorney (based on calendar year) as a result of the bill’s establishment of a \$175,000 salary for calendar 2015 and beyond.
