AMENDMENTS TO HOUSE BILL 1140, AS AMENDED

(First Reading File Bill)

AMENDMENT NO. 1

On page 1 of the bill, in line 11, after "prizes;" insert "<u>authorizing certain qualified organizations to offer or award certain cash prizes under certain circumstances</u>;"; and in line 17, after "terms;" insert "<u>providing that this Act does not apply until a certain date to a certain county</u>;".

On page 1 of the Committee on Ways and Means Amendments (HB1140/285262/2), in line 3 of Amendment No. 1, after "counties" insert "; providing that a certain qualified organization authorized to operate a certain machine may conduct a charitable casino event".

AMENDMENT NO. 2

On page 9 of the bill, in line 12, after "(1)" insert "EXCEPT AS PROVIDED IN SUBSECTION (F) OF THIS SECTION,"; and after line 20, insert:

- "(F) A QUALIFIED ORGANIZATION MAY OFFER OR AWARD A CASH PRIZE IF:
- (1) THE QUALIFIED ORGANIZATION OFFERED OR AWARDED A
 CASH PRIZE ON OR BEFORE APRIL 1, 2014; AND
 - (2) THE CASH PRIZE DOES NOT EXCEED \$2,500.";

and in lines 21 and 24, strike "(F)" and "(G)", respectively, and substitute "(G)" and "(H)", respectively.

On page 11 of the bill, after line 13, insert:

HB1140/213523/2 Amendments to HB 1140 Page 2 of 2

"SECTION 2. AND BE IT FURTHER ENACTED, That this Act does not apply until June 1, 2016, to a county that authorized charitable casino events as of October 1, 2014.";

and in line 14, strike "2." and substitute "3.".

AMENDMENT NO. 3

On page 3 of the Committee on Ways and Means Amendments, in line 3 of Amendment No. 8, after "BASED." insert:

- "(G) A QUALIFIED ORGANIZATION MAY CONDUCT A CHARITABLE CASINO EVENT IF THE ORGANIZATION HAS BEEN AUTHORIZED TO OPERATE:
- (1) AN INSTANT TICKET LOTTERY MACHINE DESCRIBED IN § 9-112
 OF THE STATE GOVERNMENT ARTICLE;
- (2) A SLOT MACHINE, AS DEFINED IN § 12-301 OF THIS ARTICLE; OR
- (3) AN ELECTRONIC INSTANT BINGO MACHINE DESCRIBED IN § 12-308 OF THIS ARTICLE.".
