"(C) (1) THIS SUBSECTION DOES NOT APPLY TO AN EMPLOYER DESCRIBED IN SUBSECTION (B)(1) OF THIS SECTION.

(2) <u>EXCEPT AS PROVIDED IN SUBSECTION (E) OF THIS SECTION</u> AND § 3-414 OF THIS SUBTITLE, EACH EMPLOYER SHALL PAY:

(I) <u>TO EACH EMPLOYEE WHO IS SUBJECT TO BOTH THE</u> FEDERAL ACT AND THIS SUBTITLE, AT LEAST THE GREATER OF:

1.THE MINIMUM WAGE FOR THAT EMPLOYEE UNDERTHE FEDERAL ACT; OR
