(II) IF THE HOLDER OF A LICENSE HAS BEEN FOUND BY THE BOARD OF LICENSE COMMISSIONERS TO HAVE VIOLATED A RESTRICTION ON SELLING LIQUOR ON SUNDAY, THE BOARD OF LICENSE COMMISSIONERS MAY NOT ISSUE A SPECIAL SUNDAY OFF-SALE PERMIT TO THE HOLDER BEFORE:

**<u>1.</u>** JANUARY 1, 2016, IF THE HOLDER:

<u>A.</u> <u>COMMITTED ONLY ONE VIOLATION BETWEEN</u> JULY 1, 2014, AND JUNE 30, 2015, BOTH INCLUSIVE; AND

B. DID NOT COMMIT A VIOLATION OF A RESTRICTION ON SELLING LIQUOR ON SUNDAY BETWEEN JULY 1, 2013, AND JUNE 30, 2014, BOTH INCLUSIVE; OR

<u>2.</u> <u>July 1, 2016, if the holder committed at</u> <u>LEAST TWO VIOLATIONS BETWEEN JULY 1, 2013, AND JUNE 30, 2015, BOTH</u> <u>INCLUSIVE.</u>

(5) THE BOARD OF LICENSE COMMISSIONERS MAY NOT ISSUE A SPECIAL SUNDAY OFF-SALE PERMIT TO A HOLDER OF A LICENSE LISTED IN PARAGRAPH (2) OF THIS SUBSECTION THAT WAS FOUND BY THE BOARD OF LICENSE COMMISSIONERS TO HAVE VIOLATED A RESTRICTION ON SELLING LIQUOR ON SUNDAY WITHOUT A SPECIAL SUNDAY OFF-SALE PERMIT ON OR AFTER JULY 1, 2015. (6) (1) EXCEPT AS PROVIDED IN SUBPARAGRAPH (11) OF THIS PARAGRAPH, AN APPLICANT FOR A SPECIAL SUNDAY OFF-SALE PERMIT SHALL COMMIT IN THE APPLICATION TO REINVESTING A MINIMUM OF \$50,000 IN THE BUSINESS WITHIN 1 YEAR AFTER THE PERMIT IS ISSUED.

2. <u>The holder of the special Sunday off-sale</u> <u>Permit fails to make the required reinvestment.</u>";
