3 4 5	(2) A person, while hunting for any wild bird or mammal, may not shoot or discharge any firearm within 300 yards of a public or nonpublic school during school hours or at a time when a school–approved activity is taking place.
6 7 8 9	(3) (i) For archery hunters in CALVERT COUNTY , Carroll [County or] COUNTY , Frederick County, OR ST. MARY'S COUNTY , the safety zone described in paragraph (1) of this subsection extends for 50 yards from a dwelling house, residence, church, or any other building or camp occupied by human beings.
10 11 12	(ii) For archery hunters in Harford County or Montgomery County, the safety zone described in paragraph (1) of this subsection extends for 100 yards from a dwelling house, residence, church, or any other building or camp occupied by human beings.
13 14 15	(4) During any open hunting season, a person, other than the owner or occupant, may not hunt or chase willfully any wild bird or mammal within the safety zone without the specific advance permission of the owner or occupant.
