| Maryland Tort Claims Act – <u>Claim Requirement and</u> Limit on Liability |
| FOR the purpose of increasing the limit on liability of the State and its units under the Maryland Tort Claims Act for injuries to a claimant arising from an incident or occurrence; <u>authorizing a court to entertain a suit under the Maryland Tort Claims Act under certain circumstances, even if a certain claim was not submitted;</u> providing for the application of this Act; and generally relating to the limits on liability of the State and its units under the Maryland Tort Claims Act. |

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

3 Article – State Government

- 4 12–104.
- 5 (a) (1) Subject to the exclusions and limitations in this subtitle and 6 notwithstanding any other provision of law, the immunity of the State and of its units is 7 waived as to a tort action, in a court of the State, to the extent provided under paragraph 8 (2) of this subsection.
- 9 (2) The liability of the State and its units may not exceed [\$200,000] 10 **\$500,000 \$400,000** to a single claimant for injuries arising from a single incident or occurrence.
- 12 (b) Immunity is not waived under this section as described under § 5–522(a) of 13 the Courts and Judicial Proceedings Article.
- 14 (c) (1) The Treasurer may pay from the State Insurance Trust Fund all or part 15 of that portion of a tort claim which exceeds the limitation on liability established under 16 subsection (a)(2) of this section under the following conditions:
- 17 (i) the tort claim is one for which the State and its units have waived 18 immunity under subsections (a) and (b) of this section;
- 19 (ii) a judgment or settlement has been entered granting the claimant 20 damages to the full amount established under subsection (a)(2) of this section; and
- 21 (iii) the Board of Public Works, with the advice and counsel of the 22 Attorney General, has approved the payment.
- 23 (2) Any payment of part of a settlement or judgment under this subsection 24 does not abrogate the sovereign immunity of the State or any units beyond the waiver 25 provided in subsections (a) and (b) of this section.
