- [(d)] (E) (1) For purposes of this subsection, an act of "graffiti" means a permanent drawing, permanent painting, or a permanent mark or inscription on the property of another without the permission of the owner of the property.
  - (2) In addition to the penalties set forth in [subsections (b) and (c)] SUBSECTIONS (C) AND (D) of this section, the court shall order a person convicted of causing malicious destruction by an act of graffiti to pay restitution or perform community service or both.

- [(f)] (G) (1) The value of damage is not a substantive element of a crime under this section and need not be stated in the charging document.

- 20 (3) If it cannot be determined from the evidence whether the value of the damage to the property is more or less than \$1,000, the value is deemed to be less than \$22 \$1,000.

- 25 (j) "Property of another" means property in which a person other than the offender has an interest that the offender does not have the authority to defeat or impair, even though the offender also may have an interest in the property, INCLUDING, BUT NOT 28 LIMITED TO, AN INTEREST BY TENANTS AN INTEREST BY A TENANT BY THE 29 ENTIRETY.
