1 AN ACT concerning

2 **Health – Ambulatory Surgical Facility – ~~Definition~~ Definitions**

3 FOR the purpose of altering the ~~definition~~ definitions of ~~an ambulatory surgical facility~~  
4 “ambulatory surgical facility” and “surgical services” under provisions of law  
5 governing freestanding ambulatory care facilities in the State to conform with  
6 federal Centers for Medicare and Medicaid Services regulations; and generally  
7 relating to ambulatory surgical facilities.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

2 (a) In this subtitle the following words have the meanings indicated.

3 (b) (1) "Ambulatory surgical facility" means any center, service, office facility,  
4 or other entity that:

5 (i) Operates ~~primarily~~ **EXCLUSIVELY** for the purpose of providing  
6 surgical services to patients requiring a period of postoperative observation but not  
7 requiring [overnight] hospitalization **AND IN WHICH THE EXPECTED DURATION OF**  
8 **SERVICES WOULD NOT EXCEED 24 HOURS FOLLOWING ADMISSION;** and

9 (ii) Seeks reimbursement from payors as an ambulatory surgery  
10 center.

11 (2) "Ambulatory surgical facility" does not include:

12 (i) The office of one or more health care practitioners seeking only  
13 professional reimbursement for the provisions of medical services, unless:

14 1. The office operates under contract or other agreement  
15 with a payor as an ambulatory surgical facility regardless of whether it is paid a technical  
16 or facility fee; or

17 2. The office is designated to receive ambulatory surgical  
18 referrals in accordance with utilization review or other policies adopted by a payor;

19 (ii) Any facility or service owned or operated by a hospital and  
20 regulated under Subtitle 2 of this title;

21 (iii) The office of a health care practitioner with not more than one  
22 operating room if:

23 1. The office does not receive a technical or facility fee; and

24 2. The operating room is used exclusively by the health care  
25 practitioner for patients of the health care practitioner;

26 (iv) The office of a group of health care practitioners with not more  
27 than one operating room if:

28 1. The office does not receive a technical or facility fee; and

29 2. The operating room is used exclusively by members of the  
30 group practice for patients of the group practice; or

1 (v) An office owned or operated by one or more dentists licensed  
2 under the Health Occupations Article.

3 (1) “Surgical services” [means any invasive procedure whether therapeutic or  
4 diagnostic involving the use of:

5 (1) Any cutting instrument;

6 (2) Microscopic, endoscopic, arthroscopic, or laparoscopic equipment; or

7 (3) A laser for the removal or repair of an organ or other tissue] HAS THE  
8 MEANING DEVELOPED BY THE AMERICAN COLLEGE OF SURGEONS AND  
9 INCORPORATED IN THE CENTERS FOR MEDICARE AND MEDICAID SERVICES STATE  
10 OPERATIONS MANUAL – GUIDANCE FOR SURVEYORS: AMBULATORY SURGICAL  
11 CENTERS.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
13 October 1, 2015.
