1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Inspectors**

3 FOR the purpose of authorizing the Harford County Liquor Control Board and general
4 manager to appoint alcoholic beverages inspectors as necessary to provide
5 appropriate control over any newly created alcoholic beverages licenses; repealing
6 certain provisions of law governing the authority of the Board and general manager
7 to appoint additional alcoholic beverages inspectors; and generally relating to
8 alcoholic beverages inspectors in Harford County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article 2B – Alcoholic Beverages**

2 (a) (1) The boards of license commissioners in this State may issue the
3 alcoholic beverages licenses provided for by this article in their respective jurisdictions.

4 (2) Each board may employ a secretary and inspectors, clerical and other
5 assistance as is necessary, and fix the compensation of the employees, except as otherwise
6 provided by this article.

7 (3) In this section, "Board" means the Board of License Commissioners,
8 unless otherwise noted.

9 (n) (1) This subsection applies only in Harford County.

10 (2) [In addition to any inspector who is serving prior to July 1, 1979, the]
11 **THE** Board and general manager may appoint [additional] inspectors as necessary to
12 provide appropriate control over newly created [Class A off-sale] licensees.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 October 1, 2015.
