## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **School Bus Monitoring Cameras – ~~Local Jurisdictions~~ – Civil Penalty**

3 FOR the purpose of ~~authorizing the governing body of a local jurisdiction to establish a civil~~  
4 ~~penalty, not exceeding a certain amount, for violations relating to overtaking and~~  
5 ~~passing a school vehicle that are recorded by a school bus monitoring camera;~~  
6 ~~repealing a requirement that the District Court prescribe a certain civil penalty~~  
7 altering the maximum civil penalty that the District Court may prescribe for a  
8 violation recorded by a school bus monitoring camera; and generally relating to civil  
9 penalties for violations recorded by school bus monitoring cameras.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

16 That the Laws of Maryland read as follows:

1 (e) (1) Unless the driver of the motor vehicle received a citation from a police  
2 officer at the time of the violation, the owner or, in accordance with subsection (h)(5) of this  
3 section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is  
4 recorded by a school bus monitoring camera during the commission of a violation.

5 (2) A ~~LOCAL JURISDICTION MAY ESTABLISH A~~ civil penalty under this  
6 subsection ~~that may not exceed \$250~~ **NOT EXCEEDING \$500.**

7 (3) For purposes of this section, the District Court shall prescribe~~§~~:

8 (i) A~~§~~ ~~A~~ uniform citation form consistent with subsection (f)(1) of  
9 this section and § 7-302 of the Courts Article~~§~~; and

10 (ii) A civil penalty, which shall be indicated on the citation, to be paid  
11 by persons who choose to prepay the civil penalty without appearing in District Court~~§~~.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
13 October 1, 2015.
