3 FOR the purpose of requiring the Governor to appoint each member of the Board of Morticians and Funeral Directors from a list of names submitted to the Governor by 4 certain entities; requiring a certain list of names to the Governor; requiring the $\mathbf{5}$ 6 Board to provide notice of a member vacancy to certain persons; requiring a certain 7 notice to include certain information; requiring the Board to develop guidelines for the solicitation of nominations and balloting process that to the extent practicable 8 9 will result in a certain Board composition reflecting certain diversity of the State; 10 clarifying that the manner in which a health occupations board is required to give 11 notice of a board vacancy is subject to a certain exception; and generally relating to 12 the State Board of Morticians and Funeral Directors and member vacancies.
