# 2 Charles County – Alcoholic Beverages – Certification for License Application

FOR the purpose of requiring the Treasurer of Charles County, instead of the Office of the
County Supervisor of Assessments, to prepare a certification showing the value of
certain merchandise, fixtures, and stock-in-trade, as certified to the county by the
State Department of Assessments and Taxation, for a business for which an
application is made for a certain alcoholic beverages license; making conforming
changes; and generally relating to license application requirements for alcoholic
beverages licenses in Charles County.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

29 30 31	(i) (1) In Charles County, the Board of License Commissioners may not renew any license as authorized in subsection (a) of this section unless there is presented to the Board a certification from the <b>TREASURER OF THE COUNTY SHOWING</b> :

This section permits the transfer of location and the assignment of license in the same application.
8 9 10	(4) A board may not permit the transfer of an alcoholic beverages license until the transferor has complied with the Bulk Transfers Act, Commercial Law Article, Title 6, and has certified such compliance, by affidavit, to the board.
