Commercial Law – Consumer Protection – "Mug Shot" Web Sites

3 FOR the purpose of authorizing an individual to request an operator of a Web site to remove 4 the individual's photograph or digital image from the operator's Web site under $\mathbf{5}$ certain circumstances; requiring an individual to make a certain request for removal 6 of a photograph or digital image in a certain manner; requiring an operator of a Web 7 site to remove the photograph or digital image of an individual within a certain 8 period of time and to send a certain written confirmation to the individual within a 9 certain period of time, under certain circumstances; prohibiting an operator of a Web 10 site from charging an individual for the removal of the individual's photograph or 11 digital image under this Act; making a violation of this Act an unfair or deceptive 12 trade practice under the Maryland Consumer Protection Act and subject to certain 13enforcement and penalty provisions; providing for the application of this Act; and generally relating to the removal of photographs and digital images from Web sites. 14

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 21 That the Laws of Maryland read as follows:

2 (A) THIS SECTION APPLIES TO THE OPERATOR OF A WEB SITE THAT 3 <u>CHARGES A FEE TO REMOVE AN ARREST OR DETENTION PHOTOGRAPH OR DIGITAL</u> 4 <u>IMAGE.</u>

5 (B) AN INDIVIDUAL MAY REQUEST AN OPERATOR OF A WEB SITE TO 6 REMOVE THE INDIVIDUAL'S PHOTOGRAPH OR DIGITAL IMAGE FROM THE 7 OPERATOR'S WEB SITE IF:

8 (1) THE PHOTOGRAPH OR DIGITAL IMAGE WAS TAKEN DURING THE 9 ARREST OR DETENTION OF THE INDIVIDUAL FOR A CRIMINAL OR TRAFFIC CHARGE 10 OR SUSPECTED VIOLATION OF A CRIMINAL OR TRAFFIC LAW; AND

11 (2) (1) THE INDIVIDUAL IS ENTITLED TO EXPUNCEMENT OF THE 12 COURT RECORD OR POLICE RECORD THAT CONTAINED THE PHOTOGRAPH OR 13 DIGITAL IMAGE WAS EXPUNGED UNDER TITLE 10, SUBTITLE 1 OF THE CRIMINAL 14 PROCEDURE ARTICLE;

15(II)THE INDIVIDUAL HAS SUCCESSFULLY PETITIONED A COURT16TO HAVE THE COURT RECORD OR POLICE RECORD THAT CONTAINED THE17PHOTOGRAPH OR DIGITAL IMAGE SHIELDED OR OTHERWISE REMOVED FROM18PUBLIC INSPECTION; OR

19(III)THE INDIVIDUAL HAS SUCCESSFULLY PETITIONED A COURT20TO VACATE THE JUDGMENT THAT RESULTED FROM THE ARREST OR DETENTION.

21(B) (C)AN INDIVIDUAL SHALL MAKE A REQUEST FOR REMOVAL OF A22PHOTOGRAPH OR DIGITAL IMAGE UNDER SUBSECTION (A) (B) OF THIS SECTION BY:

- (1) WRITTEN REQUEST SENT BY CERTIFIED MAIL; OR

24 (2) ELECTRONIC MAIL USING AN ELECTRONIC POSTMARK IF THE 25 OPERATOR MAKES AVAILABLE A SECURE ELECTRONIC MAIL CONNECTION ON THE 26 OPERATOR'S WEB SITE.

27 (C) (D) AN OPERATOR OF A WEB SITE SHALL REMOVE THE PHOTOGRAPH
28 OR DIGITAL IMAGE OF AN INDIVIDUAL WITHIN 30 DAYS AFTER RECEIVING A
29 REQUEST UNDER SUBSECTION (B) (C) OF THIS SECTION.

30 (D) (E) WITHIN 5 BUSINESS DAYS AFTER REMOVING A PHOTOGRAPH OR
 31 DIGITAL IMAGE OF AN INDIVIDUAL, THE OPERATOR OF A WEB SITE SHALL SEND A
 32 WRITTEN CONFIRMATION OF THE REMOVAL TO THE INDIVIDUAL.

1 (E) (F) AN OPERATOR OF A WEB SITE MAY NOT CHARGE AN INDIVIDUAL 2 FOR THE REMOVAL OF THE INDIVIDUAL'S PHOTOGRAPH OR DIGITAL IMAGE UNDER 3 THIS SECTION.

4 (\mathbf{F}) (G) A VIOLATION OF THIS SECTION IS:

5 (1) AN UNFAIR OR DECEPTIVE TRADE PRACTICE WITHIN THE 6 MEANING OF TITLE 13 OF THIS ARTICLE; AND

7 (2) SUBJECT TO THE ENFORCEMENT AND PENALTY PROVISIONS 8 CONTAINED IN TITLE 13 OF THIS ARTICLE.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 October 1, 2015.
