State Board of Individual Tax Preparers – Expiration and Surrender of Registrations and Civil and Criminal Penalties

- 4 FOR the purpose of providing that the registration issued to an individual tax preparer 5 remains in effect and does not expire by operation of law under certain 6 circumstances; providing that an extension of a certain registration term under 7 certain circumstances is effective only for a certain purpose; prohibiting an 8 individual tax preparer from surrendering a registration under certain 9 circumstances; establishing certain criminal penalties for violations of certain 10 provisions of law; authorizing the State Board of Individual Tax Preparers to impose 11 a certain civil penalty for violations of certain provisions of law; requiring the Board 12 to consider certain factors in setting the amount of a civil penalty; requiring the 13 Board to pay certain penalties into the General Fund of the State; and generally 14 relating to the registration of individual tax preparers and the State Board of Individual Tax Preparers. 15
