- 4 FOR the purpose of establishing a special Sunday off-sale permit in Prince George's County; authorizing the Board of License Commissioners to issue the permit to 5 6 certain license holders; authorizing the permit holder to sell certain alcoholic 7 beverages during a certain time on Sunday for consumption off the licensed 8 premises; establishing a certain fee for the permit; authorizing the Board of License Commissioners to adopt certain regulations; making conforming changes; making 9 10 stylistic changes; and generally relating to alcoholic beverages in Prince George's 11 County.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 2 That the Laws of Maryland read as follows:

Article 2B - Alcoholic Beverages

- 5 (a) This section applies only in Prince George's County.
- 6 (b) (1) (i) A holder of any retail "on–sale" alcoholic beverage license or any agent, servant or employee of a holder of any "on–sale" alcoholic beverage license may not sell or serve any alcoholic beverages for consumption on the licensed premises or permit any alcoholic beverages to be consumed on the licensed premises between the hours of 2:00 a.m. and 6:00 a.m., except as provided in subsection (c) of this section.
- 11 (ii) Holders of any "on–sale" retail alcoholic beverage license, their 12 agents, servants, or employees may sell beer and light wine on Sunday for consumption on 13 the licensed premises, except between the hours of 2:00 a.m. and 8:00 a.m.
- 14 (iii) Subject to paragraph (2) of this subsection, a holder of any Class
 15 B restaurant license, with or without [a] AN ON-SALE Sunday permit THAT AUTHORIZES
 16 THE HOLDER TO SELL LIQUOR BY THE GLASS, may sell beer, wine and liquor on Sunday
 17 when it falls on Christmas Eve or New Year's Eve, except between the hours of 2:00 a.m.
 18 and 8:00 a.m.
- 19 (2) (i) Subject to subparagraph (ii) of this paragraph, a holder of a Class 20 A retail "off–sale" alcoholic beverages license or a Class B or D alcoholic beverages license 21 with off–sale privileges, or any agent, servant or employee of the holder, may not sell any 22 alcoholic beverages for consumption off the licensed premises between the hours of 12:00
- 23 a.m. and 6:00 a.m.
- 24 (ii) A holder of a Class A beer, wine and liquor license or any agent, 25 servant or employee of a holder of a Class A beer, wine and liquor license may not make 26 any sale on Sunday after 12:00 a.m. [except when] UNLESS:
- 27 L. December 24 and 31 fall on a Sunday; OR
- 28 2. THE HOLDER OF A CLASS A BEER, WINE AND LIQUOR LICENSE HOLDS A SPECIAL SUNDAY OFF-SALE PERMIT UNDER SUBSECTION (L) OF THIS SECTION.
- 31 (f) (1) (I) [Notwithstanding any other provisions of this article, but in addition thereto] EXCEPT AS PROVIDED IN SUBSECTION (L) OF THIS SECTION AND SUBPARAGRAPH (II) OF THIS PARAGRAPH, the holder of a CLASS B beer, wine and liquor license, [Class B, his agents, servants or employees] AND AN AGENT, A SERVANT, OR AN EMPLOYEE OF A HOLDER OF A CLASS B BEER, WINE AND LIQUOR LICENSE

- 1 may not sell any alcoholic beverages for consumption off the licensed premises between the
- 2 hours of 12:00 a.m. and 6:00 a.m. or on Sunday after 12:00 a.m. from any separate store
- 3 established on the licensed premises as an "off-sale store" or to keep an "off-sale store"
- 4 open for business on Sunday after 12:00 a.m. [except that beer].
- 5 (II) BEER and light wine only may be sold from an "off-sale" store 6 which is attached to and a part of the licensed premises on Sunday after 8:00 a.m. until
- 7 12:00 a.m. the day following.
- 8 (2) For the [purpose] PURPOSES of this [provision] SUBSECTION, the
- 9 Board of License Commissioners shall determine by reasonable standards what shall
- 10 constitute an "off-sale store".
- 11 (3) Nothing further herein shall be construed to permit sales at any time
- 12 between 12:00 a.m. and 6:00 a.m. of any day.
- 13 (L) (1) THERE IS A SPECIAL SUNDAY OFF-SALE PERMIT.
- 14 (2) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE THE
- 15 PERMIT TO THE HOLDER OF:
- 16 (I) ANY CLASS A LICENSE; OR
- 17 (II) A CLASS B BEER, WINE AND LIQUOR LICENSE WITH AN
- 18 OFF-SALE PRIVILEGE.
- 19 (3) THE PERMIT AUTHORIZES THE SALE OF ALCOHOLIC BEVERAGES
- 20 THAT THE HOLDER IS AUTHORIZED TO SELL:
- 21 (I) ON SUNDAY, FROM 8 A.M. TO MIDNIGHT; AND
- 22 (II) FOR CONSUMPTION OFF THE LICENSED PREMISES ONLY.
- 23 (4) THE ANNUAL PERMIT FEE FOR THE SPECIAL SUNDAY OFF-SALE
- 24 PERMIT IS \$450, WHICH IS IN ADDITION TO THE ANNUAL FEE FOR THE CLASS A
- 25 LICENSE OR CLASS B BEER, WINE AND LIQUOR LICENSE TO WHICH IT IS ATTACHED.
- 26 (5) The Board of License Commissioners may adopt
- 27 REGULATIONS TO CARRY OUT THIS SUBSECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
- 29 1, 2015.
