2 Workers' Compensation Commission – Regulation of Fees and Charges

3 FOR the purpose of authorizing the Workers' Compensation Commission to adopt regulations about payment for the examination of a covered employee and the 4 $\mathbf{5}$ preparation of a report by a medical expert engaged by a party; authorizing the 6 Commission to regulate fees and other charges for examinations and the preparation 7 of reports by medical experts under certain provisions of law; prohibiting certain fees 8 and charges from varying based on the party responsible for paying the fee or charge; 9 and generally relating to the regulation of fees and charges by the Workers' Compensation Commission. 10
