A member of the Task Force: $\mathbf{5}$ (e) 6 may not receive compensation as a member of the Task Force; but (1)7 (2)is entitled to reimbursement for expenses under the Standard State 8 Travel Regulations, as provided in the State budget. 9 (f) The Task Force shall: 10 (1)study existing suicide prevention programs within the Department of 11 Veterans Affairs and the Department of Health and Mental Hygiene; and 12(2)develop a plan to: 13improve the effectiveness of suicide prevention programs for (i) 14veterans; and 15promote collaboration among the Department of Veterans (ii) 16Affairs, the Department of Health and Mental Hygiene, military communities in the State, 17and families of veterans in working to prevent suicide by veterans. On or before December 31, 2015, the Task Force shall report its findings and 18 (g)19the plan developed under subsection (f)(2) of this section to the Governor and, in accordance 20with § 2–1246 of the State Government Article, the General Assembly. 21SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 221, 2015. It shall remain effective for a period of 1 year and, at the end of June 30, 2016, 23with no further action required by the General Assembly, this Act shall be abrogated and
