1 AN ACT concerning

2 **State Board of Examiners of Nursing Home Administrators – Sunset Extension**
3 **and Program Evaluation**

4 FOR the purpose of continuing the State Board of Examiners of Nursing Home
5 Administrators in accordance with the provisions of the Maryland Program
6 Evaluation Act (sunset law) by repealing the termination provisions relating to the
7 statutory and regulatory authority of the Board; requiring that an evaluation of the
8 Board and the statutes and regulations that relate to the Board be performed on or
9 before a certain date; and generally relating to the State Board of Examiners of
10 Nursing Home Administrators.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
5 That the Laws of Maryland read as follows:

6 **Article – Health Occupations**

7 [9–502.

8 Subject to the evaluation and reestablishment provisions of the Program Evaluation
9 Act, this title and all rules and regulations adopted under this title shall terminate and be
10 of no effect after July 1, 2017.]

11 **Article – State Government**

12 8–403.

13 (a) On or before December 15 of the evaluation year specified, the Department
14 shall:

15 (1) conduct a preliminary evaluation of each governmental activity or unit
16 to be evaluated under this section; and

17 (2) prepare a report on each preliminary evaluation conducted.

18 (b) Each of the following governmental activities or units and the statutes and
19 regulations that relate to the governmental activities or units are subject to preliminary
20 evaluation in the evaluation year specified:

21 (37) Nursing Home Administrators, State Board of Examiners of (§ 9–201 of
22 the Health Occupations Article: [2014] **2024**);

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2015.
