A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loans of 2013 and 2014 – Baltimore City –**
3 **Skatepark of Baltimore at Roosevelt Park**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loans of 2013 and
5 2014 to change the grantees of certain grants; extending the deadline for a grantee
6 to present evidence of a certain matching fund; making this Act an emergency
7 measure; and generally relating to amending the Maryland Consolidated Capital
8 Bond Loans of 2013 and 2014.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
 33 measure, is necessary for the immediate preservation of the public health or safety, has
 34 been passed by a ye and nay vote supported by three-fifths of all the members elected to
 35 each of the two Houses of the General Assembly, and shall take effect from the date it is
 36 enacted.
