## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Education – Geographic Cost of Education – Requirement**

3 FOR the purpose of requiring that certain county boards of education receive a certain  
4 grant; repealing a certain provision that allowed for the reduction of a grant under  
5 certain circumstances; making this Act subject to a certain contingency; and  
6 generally relating to education funding in the State.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

13 That the Laws of Maryland read as follows:

14 **Article – Education**

15 5–202.

16 (f) (1) In this subsection, “GCEI adjustment” means the foundation program  
17 for each county multiplied by:

1           (2) [To the extent funds are provided in the State budget for the grants  
2 under this subsection, in] **IN** addition to the State share of the foundation program, each  
3 county board [may] **SHALL** receive a grant to reflect regional differences in the cost of  
4 education that are due to factors outside of the control of the local jurisdiction.

5           (3) [Subject to paragraph (4) of this subsection, the] **THE** amount of the  
6 grant to each county board under this subsection shall equal the GCEI adjustment for the  
7 county board multiplied times:

8                   (i) 0.50 in fiscal year 2006;

9                   (ii) 0.62 in fiscal year 2007;

10                  (iii) 0.74 in fiscal year 2008;

11                  (iv) 0.86 in fiscal year 2009; and

12                  (v) 1.00 in fiscal year 2010 and each fiscal year thereafter.

13           [(4) For any fiscal year, if sufficient funds are not provided in the State  
14 budget to fully fund the grants provided under this subsection, the grant to each county  
15 board under this subsection shall equal the amount determined under paragraph (3) of this  
16 subsection multiplied by a fraction:

17                   (i) The numerator of which is the amount provided in the State  
18 budget to fund the grants; and

19                   (ii) The denominator of which is the sum of the amounts calculated  
20 under paragraph (3) of this subsection for all the county boards.]

21           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
22 1, 2015 contingent on the fiscal year 2016 operating budget (H.B. 70/Ch. Acts of 2015)  
23 including less than 100 percent of the GCEI adjustment grant amount for each county  
24 board of education in program R00A02.01 within the Maryland State Department of  
25 Education – Aid to Education for the Geographic Cost of Education Index. If 100% of the  
26 GCEI adjustment grant amount for each county board of education in program R00A02.01  
27 within the Maryland State Department of Education – Aid to Education for the Geographic  
28 Cost of Education Index is provided in the fiscal year 2016 operating budget (H.B. 70/Ch.  
29 Acts of 2015), this Act shall be null and void without the necessity of further action by the  
30 General Assembly.
