1 AN ACT concerning

2 Education - Maryland Council on Advancement of School-Based Health Centers

3 FOR the purpose of repealing the Maryland School Board Health Center Policy Advising Committee and establishing the Maryland Council on Advancement of School-Based 4 5 Health Centers; specifying the duties of the Council; providing for the composition, 6 chair, and staffing of the Council; prohibiting a member of the Council from receiving 7 certain compensation, but authorizing the reimbursement of certain expenses; 8 requiring the Council to study and make recommendations regarding certain 9 matters; requiring the Council to report its findings and recommendations to certain 10 State agencies and the General Assembly on or before a certain date each year; 11 requiring the Council to include certain information and recommendations in a 12 certain report that is due on a certain date; repealing obsolete provisions of law; 13 specifying the terms of the initial members of the Council; and generally relating to 14 the Maryland Council on Advancement of School-Based Health Centers.

- 1 (4) A member who is appointed after a term has begun shall serve for the 2 rest of the term or until a successor is appointed and qualifies.
