### CHAPTER \_\_\_\_\_

1 AN ACT concerning

#### 2 **Alcoholic Beverages – Towne Centre at Laurel – Class A License**

3 FOR the purpose of increasing the maximum number of certain Class A alcoholic beverages  
4 licenses in Prince George’s County; authorizing the Board of License Commissioners  
5 to convert a certain Class B–DD alcoholic beverages license to be a certain Class A  
6 alcoholic beverages license to be issued to an establishment located within the Towne  
7 Centre at Laurel; *prohibiting the Board of License Commissioners from issuing more*  
8 *than a certain number of Class B–DD (Development District) licenses under certain*  
9 *circumstances*; and generally relating to alcoholic beverages licenses in Prince  
10 George’s County.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
 13 That the Laws of Maryland read as follows:

14 **Article 2B – Alcoholic Beverages**

15 9–217.

16 (a) This section applies only in Prince George’s County.

17 (b) Subject to subsection (b–1) of this section, the number of licenses of each class  
 18 of alcoholic beverage licenses may not exceed the following maximum amounts:

19 (11) Beer, wine and liquor license, Class A[142] **143**

20 (f) (7) Subject to § 6–201(r)(15) of this article, the Board of License  
 21 Commissioners may issue:

22 (iv) [Up] **SUBJECT TO SUBSECTION (O) OF THIS SECTION, UP** to  
 23 six Class B–DD (Development District) licenses [may be issued] to restaurants located  
 24 within the Towne Centre at Laurel.

25 (o) **(1) THE BOARD OF LICENSE COMMISSIONERS MAY CONVERT ONE**  
 26 **CLASS B–DD (DEVELOPMENT DISTRICT) LICENSE AUTHORIZED UNDER**  
 27 **SUBSECTION (F)(7)(IV) OF THIS SECTION TO BE A CLASS A BEER, WINE AND LIQUOR**  
 28 **LICENSE AUTHORIZED UNDER § 6–101 OF THIS ARTICLE TO BE ISSUED TO AN**  
 29 **ESTABLISHMENT LOCATED WITHIN THE TOWNE CENTRE AT LAUREL.**

30 **(2) IF THE BOARD OF LICENSE COMMISSIONERS CONVERTS A CLASS**  
 31 **B–DD (DEVELOPMENT DISTRICT) LICENSE TO A CLASS A BEER, WINE AND LIQUOR**  
 32 **LICENSE UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE BOARD OF LICENSE**  
 33 **COMMISSIONERS MAY NOT ISSUE MORE THAN 5 CLASS B–DD (DEVELOPMENT**  
 34 **DISTRICT) LICENSES UNDER SUBSECTION (F)(7)(IV) OF THIS SECTION.**

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
2 1, 2015.
