CHAPTER _____

1 AN ACT concerning

2 Harford County – Charitable Gaming

3 FOR the purpose of creating in Harford County a permit to be issued by the Sheriff of
4 Harford County that authorizes certain nonprofit organizations to conduct a gaming
5 contest in Harford County; specifying certain requirements that organizations must
6 meet to be issued a permit; specifying a certain maximum number of gaming contests
7 an organization may hold in a year and the location and hours for conducting a
8 gaming contest; authorizing certain games to be conducted at a gaming contest under
9 certain circumstances; ~~specifying the maximum bet a single individual may place on~~
10 ~~a game~~ authorizing a permit holder under this Act to charge only a preset entrance
11 fee; requiring participants in a gaming contest to use tokens and not cash for wagering
12 under certain circumstances; prohibiting a permit holder from exchanging tokens
13 under certain circumstances; requiring an individual who participates in or helps
14 operate a gaming contest to be of a certain age; specifying that alcoholic beverages
15 may be served or sold under certain conditions; prohibiting profits or proceeds from

 5 permit under certain conditions; requiring the sheriff to adopt certain regulations;

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 20 That Section(s) 13–1512 of Article – Criminal Law of the Annotated Code of Maryland be
 21 renumbered to be Section(s) 13–1513.

22 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
 23 as follows:

24 **Article – Criminal Law**

25 **13–1512.**

26 (A) IN THIS SECTION, “GAMING CONTEST” MEANS AN EVENT THAT
 27 INVOLVES A CARD GAME, A DICE GAME, OR ROULETTE.

28 (B) AN ORGANIZATION SHALL BE ISSUED A PERMIT FROM THE SHERIFF OF
 29 HARFORD COUNTY BEFORE THE ORGANIZATION MAY CONDUCT A GAMING CONTEST
 30 IN HARFORD COUNTY.

31 (C) AN ORGANIZATION IS ELIGIBLE TO BE ISSUED A PERMIT IF THE
 32 ORGANIZATION QUALIFIES AS A NONPROFIT ORGANIZATION UNDER § 501(C)(3) OR
 33 (19) OF THE INTERNAL REVENUE CODE AND HAS BEEN LOCATED IN THE COUNTY
 34 FOR AT LEAST 3 YEARS BEFORE APPLYING FOR THE PERMIT.

35 (D) TO BE ISSUED A PERMIT, AN ORGANIZATION SHALL:

1 (1) SUBMIT AN APPLICATION TO THE SHERIFF ON A FORM THAT THE
2 SHERIFF REQUIRES;

3 (2) STATE ON THE APPLICATION FORM THE PURPOSE FOR WHICH THE
4 PROCEEDS OF THE GAMING CONTEST WILL BE USED; AND

5 (3) PAY THE PERMIT FEE THAT THE SHERIFF DETERMINES.

6 (E) (1) (I) A HOLDER OF A PERMIT MAY NOT CONDUCT MORE THAN
7 FOUR GAMING CONTESTS IN A CALENDAR YEAR.

8 (II) A PERMIT IS NOT TRANSFERABLE.

9 (2) A GAMING CONTEST MAY BE HELD ONLY:

10 (I) BETWEEN 4 P.M. AND 1 A.M. THE FOLLOWING DAY; AND

11 (II) IN A STRUCTURE OR AT A LOCATION THAT IS OWNED,
12 RENTED, OR LEASED BY THE HOLDER OF THE PERMIT.

13 (3) A SEPARATE PERMIT IS REQUIRED FOR EACH GAMING CONTEST.

14 (4) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH,
15 BINGO, INSTANT BINGO, A RAFFLE, A PADDLE WHEEL, OR A 50/50 RAFFLE MAY BE
16 INCLUDED IN THE GAMES CONDUCTED AT A GAMING CONTEST.

17 (II) A GAMING CONTEST MAY NOT CONSIST EXCLUSIVELY OF A
18 GAME SPECIFIED IN SUBPARAGRAPH (I) OF THIS PARAGRAPH.

19 (F) (1) ~~THE MAXIMUM BET A SINGLE INDIVIDUAL MAY PLACE ON ANY~~
20 ~~GAME CONDUCTED DURING A GAMING CONTEST IS \$10~~ AN ORGANIZATION THAT IS
21 THE PERMIT HOLDER MAY CHARGE ONLY A PRESET ENTRANCE FEE FOR A GAMING
22 CONTEST.

23 (2) PARTICIPANTS IN A GAMING CONTEST SHALL RECEIVE TOKENS
24 FOR WAGERING IN EXCHANGE FOR THE ENTRANCE FEE.

25 (3) A PARTICIPANT MAY PURCHASE ADDITIONAL TOKENS, AT A TOTAL
26 COST NOT EXCEEDING 100% OF THE ENTRANCE FEE, DURING A GAMING CONTEST.

27 (4) AN ORGANIZATION THAT IS THE PERMIT HOLDER MAY NOT ALLOW
28 CASH TO BE USED FOR WAGERING.

1 ~~(2)~~ (5) A HOLDER OF A PERMIT MAY SERVE OR SELL ALCOHOLIC
2 BEVERAGES AT A GAMING CONTEST ONLY IF THE HOLDER IS ISSUED THE PROPER
3 LICENSE BY THE HARFORD COUNTY LIQUOR CONTROL BOARD.

6 (G) AN ORGANIZATION THAT IS THE PERMIT HOLDER MAY NOT EXCHANGE
7 TOKENS USED FOR WAGERING FOR:

8 (1) AN ITEM OF MERCHANDISE THAT IS WORTH MORE THAN \$10,000;

9 (2) MONEY; OR

10 (3) AN ITEM OF MERCHANDISE HAVING A VALUE THAT IS DIFFERENT
11 FROM THE FAIR MARKET RETAIL VALUE OF THE ITEM OF MERCHANDISE THAT WAS
12 RECEIVED FOR THE TOKENS.

13 ~~(G)~~ (H) AN ORGANIZATION MAY RENT OR PURCHASE NECESSARY
14 EQUIPMENT AND SUPPLIES TO CONDUCT A GAMING CONTEST BUT MAY NOT ENTER
15 INTO A LEASE OR OTHER AGREEMENT TO SHARE PROFITS FROM THE GAMING
16 CONTEST.

17 ~~(H)~~ (I) (1) A GAMING CONTEST SHALL BE MANAGED AND OPERATED
18 PERSONALLY BY MEMBERS OF THE ORGANIZATION CONDUCTING THE GAMING
19 CONTEST ~~WITHOUT THE ASSISTANCE OF ANY OUTSIDE WORKER, INCLUDING A PAID~~
20 ~~OR PROFESSIONAL CASINO OPERATOR, MANAGER, OR SUPPLIER OF EQUIPMENT.~~

21 (2) A MEMBER OF THE ORGANIZATION MAY NOT RECEIVE OR BE PAID
22 ANY OF THE PROCEEDS FROM THE GAMING CONTEST FOR PERSONAL USE OR
23 BENEFIT.

24 (3) A PERSON MAY NOT RECEIVE A SALARY, A COMMISSION, OR
25 COMPENSATION OF ANY KIND FOR MANAGING THE GAMING CONTEST OR OPERATING
26 A GAME PLAYED IN THE GAMING CONTEST.

27 (4) A PERSON OTHER THAN THE HOLDER OF THE PERMIT MAY NOT
28 RECEIVE OR BE PAID ANY PROCEEDS.

29 (5) TO VOLUNTEER AS AN OPERATOR OF A GAMING CONTEST, AN
30 INDIVIDUAL SHALL BE AT LEAST 18 YEARS OLD.

31 (6) TO PARTICIPATE IN A GAMING CONTEST, AN INDIVIDUAL SHALL BE
32 AT LEAST 21 YEARS OLD.

1 ~~(I)~~ (J) AFTER COSTS INCURRED IN CONDUCTING A GAMING CONTEST
2 ARE DEDUCTED, PROCEEDS FROM A GAMING CONTEST ~~MAY BE USED ONLY FOR THE~~
3 ~~PURPOSES OF THE ORGANIZATION~~ SHALL BE USED TO BENEFIT A CHARITY OR TO
4 FURTHER THE PURPOSE OF THE ORGANIZATION.

5 ~~(J)~~ (K) (1) WITHIN 30 DAYS AFTER A GAMING CONTEST, THE HOLDER
6 OF THE PERMIT SHALL SUBMIT TO THE SHERIFF A FINANCIAL REPORT THAT LISTS
7 ALL OF THE RECEIPTS AND EXPENDITURES FOR THE GAMING CONTEST.

8 (2) THE REPORT SHALL CONTAIN A FULL ACCOUNTING OF THE
9 PROCEEDS AND EXPENSES OF THE GAMING CONTEST AND THE NAME, ADDRESS, AND
10 SOCIAL SECURITY NUMBER OF A PARTICIPANT THAT IS DECLARED THE WINNER OF
11 A GAMING CONTEST REQUIRING THE ISSUANCE OF INTERNAL REVENUE SERVICE
12 FORM W-2G OR A SUBSTANTIALLY EQUIVALENT FORM.

13 (3) THE SHERIFF OR THE OFFICE OF THE HARFORD COUNTY STATE'S
14 ATTORNEY MAY REQUIRE THE HOLDER OF THE PERMIT TO PRODUCE ALL
15 FINANCIAL RECORDS OF THE GAMING CONTEST.

16 (4) THE HOLDER OF THE PERMIT SHALL KEEP ALL FINANCIAL
17 RECORDS OF THE GAMING CONTEST FOR AT LEAST 2 YEARS AFTER THE GAMING
18 CONTEST.

19 (5) THE SHERIFF MAY REFUSE TO ISSUE A PERMIT TO AN APPLICANT
20 WHO HAS FAILED TO FILE A REQUIRED REPORT FROM A PREVIOUS GAMING CONTEST
21 OR IS LATE IN FILING FEDERAL OR STATE TAX RETURNS.

22 (6) IF REQUESTED BY THE SHERIFF, THE HOLDER OF THE PERMIT
23 SHALL PAY ALL FINANCIAL AUDIT COSTS.

24 ~~(K)~~ (L) THE SHERIFF SHALL ADOPT REGULATIONS TO CARRY OUT THIS
25 SECTION.

26 ~~(L)~~ (M) ~~A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A~~
27 ~~MISDEMEANOR AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT~~
28 ~~EXCEEDING 1 YEAR OR A FINE NOT EXCEEDING \$1,000 OR BOTH~~ AN ORGANIZATION
29 THAT IS FOUND TO HAVE VIOLATED THIS SECTION IS INELIGIBLE TO RECEIVE A
30 PERMIT UNDER THIS SECTION FOR A PERIOD OF 5 YEARS.
