12 (A) DISABILITY INSURANCE UNDER § 3–302(C) OF THIS SUBTITLE MAY BE 13 PROCURED FROM A NONADMITTED INSURER IF THE COVERAGE PROCURED IS IN 14 EXCESS OF COVERAGE AVAILABLE FROM, OR IS NOT AVAILABLE FROM, AN 15 ADMITTED INSURER THAT WRITES THAT PARTICULAR KIND AND CLASS OF 16 INSURANCE IN THE STATE.

17(B) PROCUREMENT OF DISABILITY INSURANCE UNDER THIS SECTION FROM18A NONADMITTED INSURER IS SUBJECT TO:

19(1) THE DILIGENT SEARCH REQUIREMENTS OF §§ 3–306 AND 3–306.120OF THIS SUBTITLE; AND

21 (2) ALL OTHER REQUIREMENTS OF THIS SUBTITLE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to all policies and contracts of surplus lines insurance for disability insurance issued, delivered, or renewed in the State on or after October 1, 2015.

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 26 October 1, 2015.
