1 AN ACT concerning

2 **Child Abuse and Neglect – Failure to Report**

3 FOR the purpose of requiring an agency that is participating in a child abuse or neglect
4 investigation and that has reasonable grounds to believe that a person has failed to
5 report child abuse as required under a certain provision of law to file a certain
6 complaint with a certain board, agency, institution, or facility; and generally relating
7 to child abuse and neglect.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Family Law**

16 **5–705.3.**

17 **IF AN AGENCY PARTICIPATING IN AN INVESTIGATION UNDER § 5–706 OF THIS**
18 **SUBTITLE HAS REASONABLE GROUNDS TO BELIEVE THAT A PERSON HAS FAILED TO**

1 REPORT SUSPECTED ABUSE OR NEGLECT AS REQUIRED BY § 5-704 OF THIS
2 SUBTITLE, THE AGENCY SHALL:

3 (1) IF THE PERSON IS A HEALTH PRACTITIONER, FILE A COMPLAINT
4 WITH THE APPROPRIATE LICENSING BOARD IN ACCORDANCE WITH THE PROVISIONS
5 OF THE HEALTH OCCUPATIONS ARTICLE;

6 (2) IF THE PERSON IS A POLICE OFFICER, FILE A COMPLAINT WITH
7 THE APPROPRIATE LAW ENFORCEMENT AGENCY; OR

8 (3) IF THE PERSON IS AN EDUCATOR OR A HUMAN SERVICE WORKER,
9 FILE A COMPLAINT WITH THE COUNTY BOARD OF EDUCATION OR THE APPROPRIATE
10 AGENCY, INSTITUTION, OR LICENSED FACILITY AT WHICH THE PERSON IS
11 EMPLOYED.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
13 October 1, 2015.
