CHAPTER _____

1 AN ACT concerning

2 **Health Occupations – Alcohol and Drug Counselors – Qualifications and**
3 **Practice Limitations**

4 FOR the purpose of altering the qualifications individuals are required to meet to be
5 licensed to practice clinical alcohol and drug counseling, to qualify to practice as a
6 licensed graduate alcohol and drug counselor under supervision for a limited period
7 of time, to qualify as a certified associate counselor–alcohol and drug, or to qualify
8 as a certified supervised counselor–alcohol and drug; requiring a certified associate
9 counselor–alcohol and drug to practice under the supervision of a Board–approved
10 alcohol and drug supervisor who meets certain requirements; providing that a
11 certified associate counselor–alcohol and drug may only provide counseling as an
12 employee of a certain agency or facility and under the supervision of a certain
13 supervisor; prohibiting a certified associate counselor–alcohol and drug from
14 practicing independently; requiring a certified supervised counselor–alcohol and
15 drug to practice under the supervision of a Board–approved alcohol and drug

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 18 That the Laws of Maryland read as follows:

21 (a) To qualify for a license to practice clinical alcohol and drug counseling, an
 22 applicant shall be an individual who meets the requirements of this section.

23 (b) The applicant shall be of good moral character.

24 (c) The applicant shall be at least 18 years old.

25 (d) (1) Except as provided in § 17–305 of this subtitle, the applicant shall **AT**
 26 **A MINIMUM:**

27 (i) Hold a master’s or doctoral degree in a health and human
 28 services counseling field from **[an] A REGIONALLY** accredited educational institution that
 29 is approved by the Board; or

30 (ii) **[Have] HOLD A MASTER’S DEGREE FROM A REGIONALLY**
 31 **ACCREDITED EDUCATIONAL INSTITUTION AND HAVE** completed a program of studies
 32 judged by the Board to be substantially equivalent in subject matter **[and extent of**
 33 **training]** as required under this section.

1 (2) [(i) In the case of an applicant holding a doctoral degree, the
2 applicant shall have completed a minimum of 90 graduate credit hours approved by the
3 Board.

4 (ii) In the case of an applicant holding only a master's degree, the]
5 **THE** applicant shall have completed a minimum of 60 [graduate] **SEMESTER** credit hours
6 **OR 90 QUARTER CREDIT HOURS** approved by the Board.

7 (3) The applicant shall have completed a minimum of [26] ~~26~~ **39**
8 **SEMESTER** credit hours **OR 60 65 QUARTER CREDIT HOURS** in alcohol and drug
9 counselor training, including:

10 (I) **A 3 SEMESTER CREDIT HOUR OR 5 QUARTER CREDIT HOUR**

11 (f) The applicant shall provide documentation to the Board evidencing the
12 completion of 60 hours of graduate course work, completed at [an] **A REGIONALLY**
13 accredited [college or university] **EDUCATIONAL INSTITUTION** approved by the Board
14 that included training in:

16 (2) Diagnosis and treatment of mental and emotional disorders;

17 (3) Psychopathology; and

18 (4) Psychotherapy [in alcohol and drug disorders].

19 [(g) The applicant shall provide documentation evidencing the completion of 2
20 years of postgraduate supervised clinical experience as required by the Board.]

21 **[(h)] (G)** Except as otherwise provided in this title, the applicant shall pass [an]:

22 **(1) AN** examination approved by the Board; **AND**

23 **(2) THE LAW EXAMINATION ON THIS TITLE ADMINISTERED BY THE**
24 **BOARD.**

26 (a) The Board may adopt regulations to allow an individual to practice under
27 **CLINICAL** supervision as a licensed graduate alcohol and drug counselor, a licensed
28 graduate marriage and family therapist, a licensed graduate professional counselor, or a
29 licensed graduate professional art therapist.

1 (b) To qualify to practice as a licensed graduate alcohol and drug counselor, a
2 licensed graduate marriage and family therapist, a licensed graduate professional
3 counselor, or a licensed graduate professional art therapist, an individual shall be:

4 (1) Of good moral character; and

5 (2) At least 18 years old.

6 (c) An individual may practice graduate alcohol and drug counseling under
7 supervision for a limited period of time if the individual has:

18 ACCREDITED EDUCATIONAL INSTITUTION AND have completed a program of studies
19 judged by the Board to be substantially equivalent in subject matter [and extent of training
20 to such a program of studies];

21 [(2)] (3) Have completed not less than [3 years,] 1 YEAR with a minimum
22 of 2,000 hours of clinically supervised experience in alcohol and drug counseling approved
23 by the Board[, 2 years of which shall have been completed after the award of the bachelor's
24 degree]; AND

7 (II) **HOLD AN ASSOCIATE'S DEGREE FROM A REGIONALLY**
8 **ACCREDITED EDUCATIONAL INSTITUTION AND** have completed a program of studies
9 judged by the Board to be substantially equivalent in subject matter [to such a program of
10 studies]; **AND**

11 [(2) Have completed not less than 2 years, with a minimum of 2,000 hours
12 of clinically supervised experience in alcohol and drug counseling approved by the Board, 1
13 year of which shall have been completed after the award of the associate's degree;]

14 (3) Have a minimum of [15] **24 SEMESTER** credit hours [in alcohol and
15 drug counselor training.] **OR 37 QUARTER CREDIT HOURS** including [instruction in]:

1 **(C) A CERTIFIED SUPERVISED COUNSELOR–ALCOHOL AND DRUG SHALL**
2 **PRACTICE ALCOHOL AND DRUG COUNSELING UNDER THE SUPERVISION OF A**
3 **BOARD–APPROVED ALCOHOL AND DRUG SUPERVISOR WHO IS:**

4 **(1) A LICENSED CLINICAL ALCOHOL AND DRUG COUNSELOR;**

5 **(2) A CERTIFIED PROFESSIONAL COUNSELOR–ALCOHOL AND DRUG;**

6 **(3) A CERTIFIED ASSOCIATE COUNSELOR–ALCOHOL AND DRUG;**

7 **(4) A LICENSED CLINICAL PROFESSIONAL COUNSELOR;**

8 **(5) A LICENSED CLINICAL MARRIAGE AND FAMILY THERAPIST;**

9 **(6) A LICENSED CLINICAL PROFESSIONAL ART THERAPIST; OR**

10 **(7) A HEALTH CARE PROVIDER LICENSED UNDER THIS ARTICLE WITH**
11 **DOCUMENTED EXPERTISE IN ALCOHOL AND DRUG COUNSELING.**

12 **(D) A CERTIFIED SUPERVISED COUNSELOR–ALCOHOL AND DRUG:**

13 **(1) MAY PROVIDE ONLY:**

14 **(I) ALCOHOL AND DRUG COUNSELING AS AN EMPLOYEE OF AN**
15 **AGENCY OR FACILITY THAT IS CERTIFIED OR LICENSED BY THE STATE; AND**

16 **(II) ALCOHOL AND DRUG COUNSELING UNDER THE**
17 **SUPERVISION OF A BOARD–APPROVED SUPERVISOR AS SPECIFIED IN SUBSECTION**
18 **(C) OF THIS SECTION; AND**

19 **(2) MAY NOT:**

20 **(I) PROVIDE SUPERVISION; OR**

21 **(II) PRACTICE INDEPENDENTLY.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2015.
