Washington County - State Board of Education and the Professional Standards
 and Teacher Education Board - Alternative Teacher Certification Program

FOR the purpose of authorizing the Washington County State Board of Education, the Professional Standards and Teacher Education Board, and a certain number of local education agencies to establish consider and, if appropriate, develop an alternative teacher certification program for certain areas of the State; authorizing the Board to declare a critical teacher shortage and certify certain candidates to fill certain teacher shortage vacancies in certain areas during a certain time period; specifying who may fill a certain vacant position during the school year; providing that a candidate hired to fill a critical shortage teacher vacancy is not eligible for a certain certificate except under certain circumstances; requiring that certain local education agencies be chosen by the State Superintendent of Schools and be from certain areas; requiring the State Board of Education, the Professional Standards and Teacher Education Board, and certain local education agencies to consider certain criteria in the consideration of the development of a certain program; requiring the State Board of Education to submit certain information to the General Assembly on or before a certain date; and generally relating to an alternative teacher certification program in Washington County and the State Board of Education and the Professional Standards and Teacher Education Board.
