## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Public Health – Maryland AIDS Drug Assistance Program – Expansion of**  
3 **Eligibility and Services – Pharmaceutical Rebate Coverage**

4 FOR the purpose of authorizing certain rebates received by the Department of Health and  
5 Mental Hygiene from the Maryland AIDS Drug Assistance Program to be used to  
6 provide certain services to eligible individuals as allowable under Part B of the  
7 federal Ryan White HIV/AIDS Program; and generally relating to the Maryland  
8 AIDS Drug Assistance Program.

9 BY repealing and reenacting, with amendments,  
10 Article – Health – General  
11 Section 2–104(j)  
12 Annotated Code of Maryland  
13 (2009 Replacement Volume and 2014 Supplement)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That the Laws of Maryland read as follows:

16 **Article – Health – General**

17 2–104.

1 (j) (1) Except as otherwise provided by law and paragraph (2) of this  
2 subsection, the Secretary shall pay all money collected by the Department under this article  
3 into the General Fund of this State.

4 (2) Any rebates received by the Department from the Maryland AIDS Drug  
5 Assistance Program shall be distributed to a special nonlapsing fund that is not subject to  
6 § 7-302 of the State Finance and Procurement Article, to be used only to fund [the]:

7 (I) THE Maryland AIDS Drug Assistance Program [and the]  
8 (MADAP);

9 (II) THE Maryland AIDS Drug Assistance Program Plus  
10 (MADAP-Plus); AND

11 (III) ANY OTHER SERVICES TO ELIGIBLE INDIVIDUALS AS  
12 ALLOWABLE UNDER PART B OF THE FEDERAL RYAN WHITE HIV/AIDS PROGRAM.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
14 1, 2015.
