On page 4, in line 6, strike "<u>(A)</u>" and substitute "<u>(B)</u>"; strike beginning with "§ <u>12-624</u>" in line 9 down through "<u>ARTICLE</u>" in line 10 and substitute "<u>STATE LAW</u>"; strike in their entirety lines 18 through 22, inclusive, and substitute:
