AMENDMENT NO. 1

On page 1, in line 2, strike "License" and substitute "<u>and Entertainment Center</u> <u>License</u>"; in line 5, after "requirement;" insert "<u>altering the scope of a Class EC</u> (<u>entertainment center</u>) license so that it may be issued to a holder of a Class B beer, <u>wine, and liquor license</u>;"; in the same line, strike "a"; in the same line, strike "correction" and substitute "<u>corrections</u>"; in line 13, strike "(S.B. __)(6lr1406)" and substitute "(<u>S.B. 724</u>)"; and in line 17, after "Section" insert "<u>20-1008 and</u>".

<u>AMENDMENT NO. 2</u>

On page 2, before line 1, insert:

"<u>20–1008.</u>

(a) <u>There is a Class [MEC (micro-brewery/entertainment center)] EC</u> (ENTERTAINMENT CENTER) license.

(b) The Board may issue the license to a person for use in conjunction with:

(I) <u>a Class 7 micro-brewery license that the person then obtains from</u> <u>the Comptroller; OR</u>

(II) <u>A CLASS B BEER, WINE, AND LIQUOR LICENSE THAT THE</u> PERSON HAS BEEN ISSUED BY THE BOARD.

(c) (1) The EC license authorizes the license holder to sell, in an entertainment center for on-premises consumption[,]:

(I) malt beverages that are brewed in the license holder's microbrewery, IF THE LICENSE HOLDER ALSO HOLDS A CLASS 7 MICRO-BREWERY LICENSE; OR

(II) BEER, WINE, AND LIQUOR, IF THE LICENSE HOLDER ALSO HOLDS A CLASS B BEER, WINE, AND LIQUOR LICENSE.

- (2) <u>The entertainment center may:</u>
 - (i) <u>contain:</u>
 - <u>1.</u> <u>rides and games such as bowling lanes, billiard tables,</u>

and go-carts; and

- 2. <u>one or more food service facilities, bars, or lounges; and</u>
- (ii) allow the playing of music and dancing.

(d) <u>The [license holder may sell beer, wine, and liquor] HOURS OF SALE ARE:</u>

(1) on Monday through Saturday, from 6 a.m. to 2 a.m. the following day; and

- (2) on Sunday, from 11 a.m. to 2 a.m. the following day.
- (e) The annual **EC** license fee is \$1,500.".
