## Health - Milk Products - Raw Milk - Consumer-Owned Livestock

- 3 FOR the purpose of exempting from certain regulation the distribution of raw milk and raw milk products from certain producers directly to the final consumer if the consumer 4 5 has a certain ownership interest in certain animals; requiring a certain consumer 6 and a certain producer to enter into a written contract of agistment relating to a 7 certain ownership interest; establishing that the exemption does not apply to certain 8 sales of milk and milk products; providing that the prohibition on the sale of raw 9 milk for human consumption is subject to the exemption; and generally relating to the regulation of the sale of milk and milk products for human consumption. 10

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 17 That the Laws of Maryland read as follows:

## 18 Article – Health – General

- 19 21–403.
- 20 **(A)** This subtitle applies only to milk products that are intended for sale for 21 immediate or eventual human consumption.
- 22 (B) (1) THE DISTRIBUTION OF RAW MILK AND RAW MILK PRODUCTS 23 FROM MILK PRODUCERS DIRECTLY TO THE FINAL CONSUMER IS EXEMPT FROM 24 REGULATION UNDER THIS SUBTITLE IF THE CONSUMER HAS ACQUIRED AN

- OWNERSHIP INTEREST IN THE ANIMAL OR HERD FROM WHICH THE RAW MILK IS PRODUCED.
- 3 (2) THE CONSUMER AND THE MILK PRODUCER SHALL ENTER INTO A 4 WRITTEN CONTRACT OF AGISTMENT RELATING TO THE OWNERSHIP INTEREST
- 5 DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION.
- 6 (3) PARAGRAPH (1) OF THIS SUBSECTION DOES NOT APPLY TO RESTAURANT, RETAIL, COMMERCIAL, WHOLESALE, OR OTHER SALES OF MILK AND MILK PRODUCTS TO A SUBSEQUENT BUYER.

- [Except] SUBJECT TO § 21–403(B) OF THIS SUBTITLE AND EXCEPT for sale of raw milk by a holder of a milk producer permit to a holder of a milk processor permit or the sale of a farmstead cheese, a person may not sell raw milk for human consumption.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2016.
