A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – School Board Nominating Commission – Membership**

3 FOR the purpose of altering the membership of the School Board Nominating Commission
4 of Anne Arundel County to provide that, beginning on a certain date and every
5 certain number of years thereafter, one member shall be appointed by certain
6 chambers of commerce on a rotating basis in a specified order; altering the term of
7 the member appointed by a chamber of commerce; providing for the termination of
8 the term of a certain member of the Commission; and generally relating to the
9 membership of the School Board Nominating Commission of Anne Arundel County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Education**

18 3–110.

19 (b) (1) (i) There is a School Board Nominating Commission of Anne
20 Arundel County.

21 (ii) The purpose of the Commission is to select nominees to be
22 recommended to the Governor as qualified candidates for appointment to the Anne Arundel
23 County Board of Education.

1 (iii) The Commission shall hold at least two public hearings on the
 2 selection of nominees before recommending to the Governor nominees for appointment to
 3 the county board.

4 (2) (i) The Commission consists of 11 members who shall be appointed
 5 in accordance with this paragraph.

6 (ii) The Governor shall appoint five members, one from each
 7 legislative district that lies in whole or in part in Anne Arundel County.

8 (iii) The County Executive of Anne Arundel County shall appoint one
 9 member from the county at large.

10 (iv) The following organizations shall each appoint one member:

11 1. The Teachers Association of Anne Arundel County;

12 2. [The Annapolis and Anne Arundel County Chamber of
 13 Commerce;

14 3.] The Anne Arundel County Council of Parent Teacher
 15 Associations;

16 [4.] 3. The Anne Arundel County Community College
 17 Board of Trustees; and

18 [5.] 4. The Association of Educational Leaders (AEL).

19 (v) **BEGINNING JULY 1, 2016, AND EVERY 2 YEARS**
 20 **THEREAFTER, ONE MEMBER SHALL BE APPOINTED BY A CHAMBER OF COMMERCE**
 21 **BASED IN ANNE ARUNDEL COUNTY ON A ROTATING BASIS IN THE FOLLOWING**
 22 **ORDER:**

23 1. **THE WEST ANNE ARUNDEL COUNTY CHAMBER OF**
 24 **COMMERCE;**

25 2. **THE NORTHERN ANNE ARUNDEL COUNTY CHAMBER**
 26 **OF COMMERCE;**

27 3. **THE SOUTHERN ANNE ARUNDEL CHAMBER OF**
 28 **COMMERCE;**

29 4. **THE GREATER CROFTON CHAMBER OF COMMERCE;**
