A BILL ENTITLED

1 AN ACT concerning

2 Baltimore County – Elections for Judges of the Orphans' Court – Procedures

3 FOR the purpose of providing that certain provisions of law govern the nomination and 4 election of judges of the orphans' court in Baltimore County; authorizing a candidate $\mathbf{5}$ for judge of the orphans' court in Baltimore County to file and appear on certain 6 primary election ballots; requiring that certain candidates appear on the general 7 election ballot; prohibiting the political affiliation of certain candidates from being 8 included on the general election ballot; providing for the application of certain 9 provisions of this Act; making a conforming change; and generally relating to the procedures for the election of judges of the orphans' court in Baltimore County. 10

7 (A) A CANDIDATE FOR JUDGE OF THE ORPHANS' COURT MAY FILE AND 8 APPEAR ON THE PRIMARY ELECTION BALLOT OF BOTH PRINCIPAL POLITICAL 9 PARTIES.

10 **(B)** THE THREE CANDIDATES WHO RECEIVE THE LARGEST NUMBER OF 11 VOTES IN THE PRIMARY ELECTION OF EACH PRINCIPAL POLITICAL PARTY SHALL 12 APPEAR ON THE GENERAL ELECTION BALLOT.

13(C)THE POLITICAL PARTY AFFILIATION OF THE CANDIDATES MAY NOT BE14INCLUDED ON THE GENERAL ELECTION BALLOT.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 16 October 1, 2016.
