3 **Approval**

4 FOR the purpose of altering a certain provision of law to require the Athletic Trainer
5 Advisory Committee to recommend to the State Board of Physicians approval,
6 modification, or disapproval of individual evaluation and treatment protocols;
7 authorizing, under certain circumstances, an athletic trainer to assume duties under
8 an evaluation and treatment protocol after receiving a certain recommendation from
9 the Committee; providing that certain specialized tasks may only be performed after
10 an athletic trainer receives certain approval from the Board; authorizing the Board
11 to disapprove, under certain circumstances, an evaluation and treatment protocol
12 and specialized tasks included in an evaluation and treatment protocol; requiring
13 the Board, under certain circumstances, to send certain notice to a primary
14 supervising physician and an athletic trainer; requiring an athletic trainer who
15 receives notice of a certain disapproval to cease practicing under a certain evaluation
16 and treatment protocol or performing a certain specialized task; providing that a
17 member of the Board is not civilly liable for certain actions and omissions; making a
18 conforming change; the definition of “practice athletic training” to include instruction
19 to tactical athletes regarding the care and prevention of athletic injuries while
20 engaging in tactical athletic activity; granting, except under certain circumstances,
21 immunity from civil liability to a member of the State Board of Physicians for an act
22 or omission relating to the approval of a certain evaluation and treatment protocol;
23 authorizing an athletic trainer to assume certain duties under an evaluation and
24 treatment protocol on the date of receipt by the Board of a written recommendation

(a) In addition to the powers set forth elsewhere in this subtitle, the Committee shall:

(1) Develop and recommend to the Board regulations to carry out this subtitle;

(2) Develop and recommend to the Board continuing education requirements for license renewal;

(3) Provide the Board with recommendations concerning the practice of athletic training;

(4) Develop and recommend to the Board an evaluation and treatment protocol for use by an athletic trainer and the physician with whom the athletic trainer practices;

(5) [Provide advice and recommendations] RECOMMEND to the Board [on] APPROVAL, MODIFICATION, OR DISAPPROVAL OF individual evaluation and treatment protocols [when requested];

(6) Keep a record of its proceedings; and

(7) Submit an annual report to the Board.

(b) The Board shall:

(1) Consider all recommendations of the Committee; and

(2) Provide to the Committee an annual report on the disciplinary matters involving licensees.

1 (a) Nothing in this title may be construed to authorize an athletic trainer to
2 practice except under the supervision of a licensed physician and in an approved setting.

3 (b) Before an athletic trainer may practice athletic training, the athletic trainer
4 shall:

5 (1) Obtain a license under this subtitle;

6 (2) Enter into a written evaluation and treatment protocol with a licensed
7 physician; and

8 (3) ~~Obtain~~ **EXCEPT AS PROVIDED IN § 14-5D-11.3(A) OF THIS**
9 **SUBTITLE, OBTAIN** Board approval of the evaluation and treatment protocol.

10 (c) An evaluation and treatment protocol shall:

11 (1) Describe the qualifications of the licensed physician and licensed
12 athletic trainer;

13 (2) Describe the settings where the athletic trainer may practice;

14 (3) Describe the physician supervision mechanisms that the physician will
15 use to give direction to the athletic trainer;

16 (4) Specify the treatment procedures the athletic trainer may perform;

17 (5) Describe tasks the athletic trainer may not perform;

18 (6) Describe specialized tasks the supervising physician is delegating to the
19 athletic trainer to perform with documentation of competencies, certification, credentials,
20 or any other requirements established by the Board to support the delegation of the
21 specialized tasks;

22 (7) Indicate whether the athletic trainer may accept outside referrals from
23 nonsupervising physicians and other licensed health care practitioners;

24 (8) Designate an alternate supervising physician, if appropriate or
25 necessary; and

26 (9) Contain an attestation that states the supervising physician will be
27 responsible for providing ongoing and immediately available instruction that is adequate
28 to ensure the safety and welfare of a patient and is appropriate to the setting.

29 (d) An athletic trainer may accept an outside referral from a nonsupervising
30 physician or licensed health care practitioner if:

1 (1) The supervising physician specifies in the evaluation and treatment
2 protocol that the athletic trainer may accept referrals from a nonsupervising physician or
3 licensed health care practitioner;

4 (2) The nonsupervising physician or licensed health care practitioner has
5 seen the athlete and has written an order for the care of the athlete; and

6 (3) The treatment procedures to be used by the athletic trainer are:

7 (i) Within the scope of practice of an athletic trainer; and

8 (ii) Included in the evaluation and treatment protocol that the
9 athletic trainer has entered into with the supervising physician.

10 (e) In the event of a sudden departure, incapacity, or death of a supervising
11 physician, a designated alternate supervising physician may assume the role of the
12 supervising physician by submitting an evaluation and treatment protocol to the Board
13 within 15 days of the event.

(A) (1) AN ATHLETIC TRAINER MAY ASSUME THE DUTIES UNDER AN EVALUATION AND TREATMENT PROTOCOL AFTER RECEIVING A WRITTEN RECOMMENDATION OF APPROVAL FROM THE COMMITTEE IF:

(I) THE EVALUATION AND TREATMENT PROTOCOL DOES NOT INCLUDE SPECIALIZED TASKS; OR

(II) THE EVALUATION AND TREATMENT PROTOCOL INCLUDES SPECIALIZED TASKS THAT THE BOARD PREVIOUSLY HAS APPROVED UNDER § 14-5D-11 OF THIS SUBTITLE.

1 **(2) IF AN EVALUATION AND TREATMENT PROTOCOL INCLUDES**
2 **SPECIALIZED TASKS THAT HAVE NOT BEEN PREVIOUSLY APPROVED BY THE BOARD**
3 **UNDER § 14-5D-11 OF THIS SUBTITLE, AN ATHLETIC TRAINER MAY ONLY PERFORM**
4 **THE SPECIALIZED TASK AFTER RECEIVING WRITTEN APPROVAL FROM THE BOARD.**

5 **(B) THE BOARD MAY DISAPPROVE AN EVALUATION AND TREATMENT**
6 **PROTOCOL OR A SPECIALIZED TASK INCLUDED IN THE EVALUATION AND**
7 **TREATMENT PROTOCOL IF THE BOARD DETERMINES THAT:**

8 **(1) THE EVALUATION AND TREATMENT PROTOCOL DOES NOT MEET**

16 **PROTOCOL, THE BOARD SHALL SEND TO THE PRIMARY SUPERVISING PHYSICIAN**
17 **AND THE ATHLETIC TRAINER WRITTEN NOTICE OF THE DISAPPROVAL.**

18 **(D) AN ATHLETIC TRAINER WHO RECEIVES NOTICE OF A DISAPPROVAL**

24 **DISAPPROVAL OF AN EVALUATION AND TREATMENT PROTOCOL.**
