20 (B) (1) BEGINNING ON JANUARY 1, 2017, A LOCAL SCHOOL SYSTEM 21 SHALL ALLOW A STUDENT PARTICIPATING IN A HOME INSTRUCTION PROGRAM TO 22 PARTICIPATE IN THE EXTRACURRICULAR CLUBS AND ACTIVITIES OF THE LOCAL 23 SCHOOL SYSTEM.
