- 21 (a) Except as provided in subsection (b) of this section, a refiner or other supplier 22 of motor fuel to a retail service station may not engage in, sponsor, promote, advertise, or 23 otherwise perform or participate in a game of chance to be marketed or offered to the public 24 at a retail service station in the State.

HOUSE BILL 342

- 1 (b) (1) A supplier of motor fuel authorized under this title to [operate] SUPPLY 2 retail service stations may, at such stations, SPONSOR, PROMOTE, ADVERTISE, OR 3 OTHERWISE PERFORM OR participate in a game of chance [promoted or sponsored by 4 entities other than a refiner or supplier of motor fuel] IF THE RETAIL SERVICE STATION 5 DEALER AGREES TO PARTICIPATE IN THE GAME OF CHANCE.
- 6 (2) A supplier of motor fuel authorized under this section to conduct a game 7 of chance may not require a retail service station dealer to [pay for any costs related to] 8 **PARTICIPATE IN** the game of chance.
- 9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 10 1, 2016.
