## A BILL ENTITLED

1 AN ACT concerning

2 **Board of Public Works Transparency Act of 2016**

3 FOR the purpose of requiring the Secretary of Budget and Management to provide certain  
4 public notice within a certain period of time before the Board of Public Works may  
5 approve a reduction of appropriations; requiring the Secretary to provide certain  
6 notice within a certain period of time to the Board of Public Works and certain  
7 committees of the General Assembly; and generally relating to the State budget and  
8 the Department of Budget and Management.

9 BY repealing and reenacting, with amendments,  
10 Article – State Finance and Procurement  
11 Section 7–213  
12 Annotated Code of Maryland  
13 (2015 Replacement Volume)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That the Laws of Maryland read as follows:

16 **Article – State Finance and Procurement**

17 7–213.

18 (a) **(1)** [Except] **SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION AND**  
19 **EXCEPT** as provided in subsection (b) of this section, with the approval of the Board of  
20 Public Works, the Governor may reduce, by not more than 25%, any appropriation:

21 **[(1)] (I)** that the Governor considers unnecessary; or

1           **[(2)] (II)** that is subject to budgetary reductions required under the budget  
2 bill as approved by the General Assembly.

3           **(2) AT LEAST 10 CONSECUTIVE DAYS BEFORE THE BOARD OF PUBLIC**  
4 **WORKS MAY APPROVE A PROPOSED REDUCTION OF AN APPROPRIATION UNDER**  
5 **THIS SUBSECTION, THE SECRETARY OF BUDGET AND MANAGEMENT SHALL:**

6           **(I) PUBLISH ON THE DEPARTMENT OF BUDGET AND**  
7 **MANAGEMENT'S WEB SITE NOTICE OF THE PROPOSED REDUCTION, INCLUDING:**

8                   **1. THE NAME OF THE STATE AGENCY OR PROGRAM FOR**  
9 **WHICH THE APPROPRIATION IS INTENDED AND A BRIEF NARRATIVE SUMMARY OF**  
10 **THE IMPACT OF THE PROPOSED REDUCTION ON THE STATE AGENCY OR PROGRAM;**

11                   **2. THE AMOUNT OF THE PROPOSED REDUCTION IN BOTH**  
12 **DOLLAR AND PERCENTAGE VALUES;**

13                   **3. THE FUND SOURCE OF THE APPROPRIATION SUBJECT**  
14 **TO THE PROPOSED REDUCTION; AND**

15                   **4. ANY PROJECTED REDUCTIONS IN WORKFORCE AS A**  
16 **RESULT OF THE PROPOSED REDUCTION;**

17           **(II) PROVIDE THE NOTICE REQUIRED UNDER SUBPARAGRAPH**  
18 **(I) OF THIS PARAGRAPH TO THE BOARD OF PUBLIC WORKS FOR PUBLICATION ON**  
19 **THE BOARD'S WEB SITE; AND**

20           **(III) PROVIDE WRITTEN NOTICE OF THE PROPOSED REDUCTION,**  
21 **INCLUDING THE ITEMS SPECIFIED UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH,**  
22 **TO:**

23                   **1. THE LEGISLATIVE POLICY COMMITTEE;**

24                   **2. THE SENATE BUDGET AND TAXATION COMMITTEE;**

25 **AND**

26                   **3. THE HOUSE APPROPRIATIONS COMMITTEE.**

27           **(b) (1)** The Governor may not reduce an appropriation to the Legislative  
28 Branch or the Judicial Branch of the State government.

29           **(2)** The Governor may not reduce an appropriation for:

30                   **(i)** payment of the principal of or interest on the State debt;

1 (ii) public schools, including the Maryland School for the Deaf;

2 (iii) the Maryland School for the Blind; or

3 (iv) the salary of a public officer, during the term of office.

4 (3) Except as provided in § 8–109 of the State Personnel and Pensions  
5 Article, the Governor may not reduce an appropriation for the salary of any nontemporary  
6 employee in the State Personnel Management System.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
8 1, 2016.
