A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Income Tax Refunds – Harford County – Warrant Intercept Program**

3 FOR the purpose of altering the requirement for the Comptroller to withhold Maryland
4 income tax refunds of certain individuals with outstanding warrants to include
5 residents of Harford County or individuals who have outstanding warrants from
6 Harford County; making nonsubstantive changes to certain termination provisions;
7 making conforming changes; providing for a delayed effective date for certain
8 provisions of this Act; and generally relating to withholding income tax refunds of
9 individuals with outstanding warrants.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
8 That the Laws of Maryland read as follows:

9 **Article – Tax – General**

10 13–935.

- 11 (a) In this part the following words have the meanings indicated.
- 12 (b) “Refund” means an individual’s Maryland income tax refund.
- 13 (c) (1) “Warrant” means a criminal arrest warrant.
- 14 (2) “Warrant” includes a warrant issued for or that results from:
- 15 (i) a failure to appear before a court of the State;
- 16 (ii) a violation of the Maryland Vehicle Law that is punishable by a
17 term of confinement; or
- 18 (iii) a violation of probation.
- 19 (3) “Warrant” does not include a body attachment.
- 20 (d) “Warrant official” means an official of the federal, State, or local government
21 charged with serving a warrant.

22 13–936.

- 23 (a) This part applies only to individuals who:
- 24 (1) are residents of Anne Arundel County, Baltimore City, **HARFORD**
25 **COUNTY**, or Washington County; or
- 26 (2) have an outstanding warrant from Anne Arundel County, Baltimore
27 City, **HARFORD COUNTY**, or Washington County.
- 28 (b) This part does not apply to an individual:

1 (1) who is an active duty member of the armed forces of the United States;
2 or

3 (2) who files a joint Maryland income tax return.

4 13–937.

5 A warrant official may:

6 (1) certify to the Comptroller the existence of an outstanding warrant for
7 an individual who is a resident of Maryland or who receives income from Maryland; and

8 (2) request the Comptroller to withhold any refund to which the individual
9 is entitled.

10 13–938.

11 (a) A certification by a warrant official to the Comptroller shall include:

12 (1) the full name and address of the individual and any other names known
13 to be used by the individual;

14 (2) the Social Security number or federal tax identification number; and

15 (3) a statement that the warrant is outstanding.

16 (b) The Comptroller shall determine if an individual for whom a certification is
17 received is due a refund.

18 (c) As to any individual due a refund for whom a certification is received, the
19 Comptroller shall:

20 (1) withhold the individual's refund; and

21 (2) notify the individual of a certification by the warrant official of the
22 existence of an outstanding warrant.

23 (d) The Comptroller may not pay a refund until the warrant official notifies the
24 Comptroller that the warrant is no longer outstanding.

25 13–939.

26 The Comptroller shall withhold and pay any amount as provided in § 13–918 of this
27 subtitle before withholding any part of an income tax refund under § 13–938 of this part.

28 13–940.

1 On or before December 1 of each year, the Office of the Comptroller shall report to
2 the House Ways and Means Committee and the Senate Budget and Taxation Committee,
3 in accordance with § 2–1246 of the State Government Article, on the implementation of §§
4 13–935 through 13–939 of this part.

5 **Chapter 451 of the Acts of 2012, as amended by Chapter 213 of the Acts of 2013**

6 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 October 1, 2012. [Section 1 of this Act shall remain effective for a period of 6 years and, at
8 the end of September 30, 2018, with no further action required by the General Assembly,
9 Section 1 of this Act shall be abrogated and of no further force and effect.]

10 **Chapter 213 of the Acts of 2013**

11 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
12 1, 2013. [Section 1 of this Act shall remain effective until the taking effect of the
13 termination provision specified in Section 3 of Chapter 451 of the Acts of 2012. If that
14 termination provision takes effect, Section 1 of this Act shall be abrogated and of no further
15 force and effect.]

16 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
17 as follows:

18 **Article – Tax – General**

19 13–936.

20 (a) This part applies only to individuals who:

21 (1) are residents of [Anne Arundel County,] Baltimore City, Harford
22 County, or Washington County; or

23 (2) have an outstanding warrant from [Anne Arundel County,] Baltimore
24 City, Harford County, or Washington County.

25 SECTION 3. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take
26 effect October 1, 2018.

27 SECTION 4. AND BE IT FURTHER ENACTED, That, except as provided in Section
28 3 of this Act, this Act shall take effect October 1, 2016.
