A BILL ENTITLED

1 AN ACT concerning

Maryland Nurse Practice Act – Peer Review and Advisory Committees and Penalties

4 FOR the purpose of repealing the requirement that the State Board of Nursing appoint $\mathbf{5}$ certain peer review committees to oversee the use of certain insurance and certain 6 benefits; authorizing the Board to appoint peer advisory committees to provide the 7 Board with certain advice; altering the maximum amount of a certain civil fine the 8 Board may impose for certain violations; altering the application of certain criminal 9 penalties; altering the maximum amount of a certain fine and the maximum term of 10 imprisonment to which a certain person is subject for certain violations; repealing 11 the exemption from certain penalties for certain persons who are licensed, certified, 12or otherwise authorized to provide health care services under certain provisions of 13 law; repealing certain definitions; and generally relating to the Maryland Nurse Practice Act. 14

(a) Subject to the hearing provisions of § 8–317 of this title and in addition to any
other sanction authorized for a violation of §§ 8–701 through 8–706 of this subtitle, the
Board may issue a public cease and desist order, impose a civil fine of not more than
[\$5,000] \$20,000 per offense, or both.

6 (a) (1) Except [for a violation of \S 8–701(a) through (e) of this subtitle] AS 7**PROVIDED IN PARAGRAPH** (2) OF THIS SUBSECTION, a person who violates any provision OF § 8-701(A) THROUGH (E), § 8-703, § 8-704, OR § 8-705 of this subtitle is 8 9 guilty of a misdemeanor and on conviction is subject to a fine not exceeding [\$5,000] 10 **\$10,000** or imprisonment not exceeding [1 year] **5** YEARS or both.

11 (2) PARAGRAPH (1) OF THIS SUBSECTION DOES NOT APPLY TO A 12LICENSEE OR CERTIFICATE HOLDER WHO HAS FAILED TO RENEW THE LICENSE OR 13CERTIFICATE WHO VIOLATES ANY PROVISION OF § 8-701(A) THROUGH (E) OR § 8–703 OF THIS SUBTITLE. 14

15Except as otherwise provided in this section, subject] **SUBJECT** to the (b) $\left[(1) \right]$ 16appropriate hearing and appeals provisions, the Board, on the affirmative vote of the 17majority of its members, may reprimand a licensee or certificate holder, place a licensee or 18 certificate holder on probation, or suspend or revoke a license or certificate of a person who 19 violates any provision of this subtitle.

20 A person who is licensed, certified, or otherwise authorized to provide (2)21health care services under this article is not subject to the penalty provided in subsections 22(a) and (b) of this section for a violation of $\S = 701(f)$ and (g) of this subtitle.

23SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 24October 1, 2016.
