2 **Courts and Judicial Proceedings – Structured Settlements – Transfers and**  
3 **Registration of Structured Settlement Transferees**

4 FOR the purpose of making certain legislative findings and declarations; altering the  
5 findings that an order of a court authorizing a transfer of certain structured  
6 settlement rights is required to be based on; requiring a transferee to provide to a  
7 payee a certain disclosure statement; requiring ~~an application~~ a petition for a  
8 transfer of structured settlement payment rights to be filed in a certain court;  
9 authorizing the Attorney General to intervene as of right in a certain action;  
10 establishing certain requirements concerning a proposed transfer of structured  
11 settlement payment rights concerning certain tort claims; prohibiting a person from  
12 filing a petition for transfer of structured settlement payment rights unless the  
13 person is registered with the Attorney General or has a pending application for  
14 registration under certain circumstances; establishing registration requirements;  
15 requiring a transferee to file a certain letter of credit or bond with the Attorney  
16 General or deposit cash in a certain amount with the Attorney General; authorizing  
17 the Attorney General to suspend or revoke the registration of a structured settlement

 35 VALUE, REGARDLESS OF FORM, AS AN INDUCEMENT TO ENTER INTO A TRANSFER  
 36 AGREEMENT OR PURSUE A TRANSFER, EXCEPT:

1           **(1) THE ACTUAL COST, NOT TO EXCEED \$100, OF THE PAYEE'S**  
2 **TRANSPORTATION TO A HEARING CONCERNING A PETITION FILED UNDER § 5-1102**  
3 **OF THIS SUBTITLE; AND**

4           **(2) THE COSTS OF POSTAGE, OVERNIGHT DELIVERY SERVICES,**  
5 **DOCUMENT RETRIEVAL FEES, AND NOTARY SERVICES ASSOCIATED WITH THE FILING**  
6 **OF A PETITION UNDER § 5-1102 OF THIS SUBTITLE.**

7           ~~(D)~~ **(D)**       “Independent professional advice” means advice of an attorney,  
8 certified public accountant, actuary, or other licensed professional adviser:

9           (1)       Who is engaged by a payee to render advice concerning [the legal, tax,  
10 and financial implications of a] **WHETHER A PROPOSED** transfer of structured settlement  
11 payment rights **WOULD BE IN THE BEST INTEREST OF THE PAYEE, TAKING INTO**  
12 **ACCOUNT THE WELFARE AND SUPPORT OF THE PAYEE'S DEPENDENTS;**

13           (2)       Who is not affiliated with or compensated by the transferee of the  
14 transfer; and

15           (3)       Whose compensation is not affected by whether a transfer occurs.

16           **[(d)] (E)**       “Interested parties” means the payee, each beneficiary designated  
17 under the annuity contract to receive payments following the payee's death, the annuity  
18 issuer, the structured settlement obligor, and any other party that has continuing rights or  
19 obligations under a structured settlement.

20           **[(e)] (F)**       “Payee” means an individual who receives damage payments that are  
21 not subject to income taxation under a structured settlement and proposes to make a  
22 transfer of payment rights.

23           **(G) “REGISTRANT” MEANS A PERSON REGISTERED WITH THE ATTORNEY**  
24 **GENERAL UNDER THIS SUBTITLE.**

25           **[(f)] (H)**       “Responsible administrative authority” means a government authority  
26 vested with exclusive jurisdiction over the settled claim resolved by a structured  
27 settlement.

28           **[(g)] (I)**       (1)       “Structured settlement” means an arrangement for periodic  
29 payment of damages for personal injury established by a settlement or judgment in  
30 resolution of a tort claim.

31           (2)       “Structured settlement” does not include an arrangement for periodic  
32 payment of damages for personal injury established by a judgment by confession.

1 [(h)] (J) “Structured settlement agreement” means an agreement, judgment,  
2 stipulation, or release embodying the terms of a structured settlement.

3 [(i)] (K) “Structured settlement obligor” means a party who has the continuing  
4 periodic payment obligation to the payee under a structured settlement agreement or a  
5 qualified assignment agreement.

6 [(j)] (L) “Structured settlement payment rights” means the rights to receive  
7 periodic payments, including lump-sum payments under a structured settlement, whether  
8 from the settlement obligor or the annuity issuer, if:

9 (1) [An interested party is domiciled] THE PAYEE RESIDES in this State;

10 (2) The structured settlement agreement was approved by a court or  
11 responsible administrative authority in this State, AND THE PAYEE DOES NOT RESIDE  
12 IN ANOTHER STATE OR JURISDICTION THAT HAS ENACTED A STATUTE PROVIDING  
13 FOR ENTRY OF A QUALIFIED ORDER AS DEFINED IN 26 U.S.C. § 58911(B)(2); or

14 (3) The settled claim was pending before a court of this State when the  
15 parties entered into the structured settlement agreement, AND THE PAYEE DOES NOT  
16 RESIDE IN ANOTHER STATE OR JURISDICTION THAT HAS ENACTED A STATUTE  
17 PROVIDING FOR ENTRY OF A QUALIFIED ORDER AS DEFINED IN 26 U.S.C. §  
18 58911(B)(2).

19 [(k)] (M) “Terms of the structured settlement” includes the terms of the  
20 structured settlement agreement, the annuity contract, a qualified assignment, and an  
21 order or approval of a court or responsible administrative authority authorizing or  
22 approving a structured settlement.

23 [(l)] (N) “Transfer” means a sale, assignment, pledge, hypothecation, or other  
24 form of alienation or encumbrance made by a payee for consideration.

25 [(m)] (O) “Transfer agreement” means the agreement providing for the transfer  
26 of structured settlement payment rights from a payee to a transferee.

27 (P) “TRANSFeree” MEANS A PERSON ACQUIRING OR PROPOSING TO  
28 ACQUIRE STRUCTURED SETTLEMENT PAYMENT RIGHTS THROUGH A TRANSFER.

30 **THE GENERAL ASSEMBLY FINDS AND DECLARES THAT IT IS NECESSARY TO**  
31 **REGULATE TRANSFERS OF STRUCTURED SETTLEMENT PAYMENT RIGHTS TO:**

32 **(1) ENSURE THAT THE TRANSFERS ARE EFFECTUATED ON FAIR AND**  
33 **REASONABLE TERMS AND ARE IN THE BEST INTERESTS OF PAYEES; AND**

1           **(2) PROTECT PAYEES AGAINST DECEPTIVE PRACTICES.**

3           (a) A direct or indirect transfer of structured settlement payment rights to a  
4 transferee is effective as provided in this subtitle.

5           (b) A structured settlement obligor or annuity issuer may not make any payment  
6 directly or indirectly to a transferee of structured settlement payment rights unless the  
7 transfer is authorized in an order of a court based on [a finding] **EXPRESS FINDINGS** that:

8           (1) The transfer is necessary, reasonable, [or] **AND** appropriate **AND IN**  
9 **THE BEST INTEREST OF THE PAYEE, TAKING INTO ACCOUNT THE WELFARE AND**  
10 **SUPPORT OF THE PAYEE'S DEPENDENTS;**

11           (2) [The transfer is not expected to subject the payee, the payee's  
12 dependents, or both, to undue or unreasonable financial hardship in the future] **THE**  
13 **FINANCIAL TERMS OF THE TRANSFER AGREEMENT ARE FAIR TO ALL PARTIES,**  
14 **TAKING INTO ACCOUNT:**

15                           **(I) THE DIFFERENCE BETWEEN THE AMOUNT PAYABLE TO THE**  
16 **PAYEE AND THE DISCOUNTED PRESENT VALUE OF THE PAYMENTS TO BE**  
17 **TRANSFERRED; AND**

18                           **(II) THE DISCOUNT RATE APPLICABLE TO THE TRANSFER;**

19           (3)† The payee received independent professional advice [regarding the  
20 legal, tax, and financial implications of] **CONCERNING** the **PROPOSED** transfer; and

29                           **(III) THE DISCOUNTED PRESENT VALUE OF THE PAYMENTS TO**  
30 **BE TRANSFERRED;**

1 (IV) THE AMOUNT PAYABLE TO THE PAYEE IN EXCHANGE FOR  
 2 THE PAYMENTS TO BE TRANSFERRED;

3 (V) AN ITEMIZED LISTING OF ALL BROKERS' COMMISSIONS,  
 4 SERVICE CHARGES, APPLICATION FEES, PROCESSING FEES, CLOSING COSTS, FILING  
 5 FEES, ADMINISTRATIVE FEES, NOTARY FEES, AND OTHER CHARGES PAYABLE BY THE  
 6 PAYEE OR DEDUCTIBLE FROM THE GROSS AMOUNT OTHERWISE PAYABLE TO THE  
 7 PAYEE, EXCEPT ATTORNEY'S FEES AND RELATED DISBURSEMENTS;

8 (VI) THE TRANSFEREE'S BEST ESTIMATE OF THE AMOUNT OF  
 9 ANY ATTORNEY'S FEES AND DISBURSEMENTS PAYABLE BY THE PAYEE OR  
 10 DEDUCTIBLE FROM THE GROSS AMOUNT OTHERWISE PAYABLE TO THE PAYEE;

11 (VII) THE NET AMOUNT PAYABLE TO THE PAYEE AFTER  
 12 DEDUCTION OF ALL COMMISSIONS, FEES, COSTS, EXPENSES, AND CHARGES  
 13 DESCRIBED IN ITEMS (V) AND (VI) OF THIS ITEM;

14 (VIII) THE DISCOUNT RATE APPLICABLE TO THE TRANSFER,  
 15 WHICH SHALL BE DISCLOSED IN THE FOLLOWING STATEMENT: "BASED ON THE NET  
 16 AMOUNT THAT YOU WILL RECEIVE FROM US AND THE AMOUNTS AND TIMING OF THE  
 17 STRUCTURED SETTLEMENT PAYMENTS THAT YOU ARE TRANSFERRING TO US, YOU  
 18 WILL, IN EFFECT, BE PAYING INTEREST TO US AT A RATE OF \_\_\_\_\_ PERCENT PER YEAR.";

19 (IX) THE AMOUNT OF ANY PENALTY OR LIQUIDATED DAMAGES  
 20 PAYABLE BY THE PAYEE IN THE EVENT OF ANY BREACH OF THE TRANSFER  
 21 AGREEMENT BY THE PAYEE; AND

22 (X) A STATEMENT THAT THE PAYEE HAS THE RIGHT TO CANCEL  
 23 THE TRANSFER AGREEMENT, WITHOUT PENALTY OR FURTHER OBLIGATION, AT ANY  
 24 TIME BEFORE THE TRANSFER IS AUTHORIZED BY A COURT UNDER THIS SUBTITLE.

 27 court for the county in which the original claim occurred shall have nonexclusive

(2) IF THE PAYEE DOES NOT RESIDE IN THIS STATE, IN THE CIRCUIT COURT:

(I) THAT APPROVED THE STRUCTURED SETTLEMENT AGREEMENT; OR

(II) IN WHICH THE SETTLED CLAIM WAS PENDING WHEN THE PARTIES ENTERED INTO THE STRUCTURED SETTLEMENT AGREEMENT, IF THE STRUCTURED SETTLEMENT WAS NOT COURT APPROVED.

(b) A transferee shall file with the court and serve on the interested parties at least 20 days before the hearing on the [application] PETITION, a notice of the proposed transfer and [an application] A PETITION for its authorization, including:

(1) A copy of the transferee's [application] PETITION;

(2) A copy of the transfer agreement; and

(3) Notification:

(i) Of the time and place of the hearing; and

(ii) That each interested party is entitled to support, oppose, or otherwise respond to the transferee's [application] PETITION, in person or by counsel, by submitting written comments to the court or by participating in the hearing.

(C) THE ATTORNEY GENERAL MAY INTERVENE AS OF RIGHT IN AN ACTION UNDER THIS SUBTITLE.

(A) IF, IN ANY PROPOSED TRANSFER OF STRUCTURED SETTLEMENT PAYMENT RIGHTS, THE STRUCTURED SETTLEMENT WAS ESTABLISHED IN RESOLUTION OF A TORT CLAIM SEEKING COMPENSATION FOR COGNITIVE INJURIES, INCLUDING ANY CLAIM ARISING FROM CHILDHOOD EXPOSURE TO LEAD PAINT, THE TRANSFEREE SHALL:

1           (1) NOTIFY THE COURT, IN THE PETITION FILED UNDER THIS  
2 SUBTITLE, THAT THE PAYEE MAY BE COGNITIVELY IMPAIRED;

3           (2) ATTACH TO THE PETITION A COPY OF ANY COMPLAINT THAT WAS  
4 PENDING WHEN THE STRUCTURED SETTLEMENT WAS ESTABLISHED; AND

5           (3) IDENTIFY ANY ALLEGATIONS OR STATEMENTS IN THE COMPLAINT  
6 THAT DESCRIBE THE NATURE, EXTENT, OR CONSEQUENCES OF THE PAYEE'S  
7 COGNITIVE INJURIES.

8           (B) (1) IN DETERMINING WHETHER TO AUTHORIZE A TRANSFER OF  
9 STRUCTURED SETTLEMENT PAYMENT RIGHTS INVOLVING A STRUCTURED  
10 SETTLEMENT ESTABLISHED IN RESOLUTION OF A TORT CLAIM SEEKING  
11 COMPENSATION FOR COGNITIVE INJURIES, INCLUDING ANY CLAIM ARISING FROM  
12 CHILDHOOD EXPOSURE TO LEAD PAINT, THE COURT SHALL CONSIDER WHETHER TO  
13 APPOINT A GUARDIAN AD LITEM FOR THE PAYEE OR TO REQUIRE THE PAYEE TO BE  
14 EXAMINED BY AN INDEPENDENT MENTAL HEALTH SPECIALIST DESIGNATED BY THE  
15 COURT.

16           (2) THE TRANSFEREE SHALL BE RESPONSIBLE FOR THE PAYMENT OF  
17 ANY FEES OF A GUARDIAN AD LITEM OR AN INDEPENDENT MENTAL HEALTH  
18 SPECIALIST APPOINTED OR DESIGNATED BY THE COURT UNDER THIS SUBSECTION,  
19 AS SET FORTH IN A BILLING STATEMENT SPECIFYING TO THE TENTH OF AN HOUR  
20 THE AMOUNT OF WORK PERFORMED AND A REASONABLE HOURLY FEE FOR THE

32 TRANSFEREE, AN APPLICANT SHALL:



1                   (I) SUBMIT TO THE ATTORNEY GENERAL UNDER OATH AN  
2 APPLICATION ON THE FORM PROVIDED BY THE ATTORNEY GENERAL; AND

3                   (II) PAY A REGISTRATION FEE OF \$2,000, OF WHICH \$1,000  
4 SHALL BE REFUNDABLE IN THE EVENT THAT THE ATTORNEY GENERAL DENIES THE  
5 APPLICATION FOR REGISTRATION.

6                   (2) ALL FEES COLLECTED UNDER THIS SUBSECTION SHALL BE USED  
7 TO ADMINISTER THE REGISTRATION PROGRAM.

8                   (3) IN THE CASE OF AN APPLICANT THAT, AT THE TIME OF ITS

14 SETTLEMENT TRANSFEREE TO REAPPLY FOR REGISTRATION ON AN ANNUAL BASIS  
15 OR LESS FREQUENTLY, AS THE ATTORNEY GENERAL DETERMINES.

16                   (2) IN THE CASE OF A REGISTRANT APPLYING FOR RENEWAL OF ITS  
17 REGISTRATION, THE ATTORNEY GENERAL SHALL GRANT OR DENY AN APPLICATION  
18 FOR REGISTRATION WITHIN 30 DAYS OF SUBMISSION OF THE COMPLETE  
19 APPLICATION AND ALL APPLICABLE FEES.

13 **MAINTAIN REGISTRATION OF NO MORE THAN FOUR TRADE NAMES; AND**

14                   **(6) ANY OTHER INFORMATION THAT THE ATTORNEY GENERAL**  
15 **REQUIRES.**

16                   **(E) IF THE ATTORNEY GENERAL DENIES AN APPLICATION FOR**  
17 **REGISTRATION, THE ATTORNEY GENERAL SHALL SPECIFY IN WRITING THE REASON**
