A BILL ENTITLED

1 AN ACT concerning

2 **Pain-Capable Unborn Child Protection Act**

3 FOR the purpose of prohibiting, except under certain circumstances, the performance or
4 inducement or attempted performance or inducement of an abortion of a pregnant
5 woman unless a certain determination as to the probable age of the unborn child is
6 made by a certain physician; providing that the failure of a physician to perform
7 certain actions is deemed “unprofessional conduct”; prohibiting the performance or
8 inducement or attempted performance or inducement of an abortion of a pregnant
9 woman if the probable age of an unborn child is a certain number of weeks, except
10 under certain circumstances; requiring an abortion to be performed in a certain
11 manner under certain circumstances; requiring certain physicians to submit a
12 certain report to the Department of Health and Mental Hygiene that includes certain
13 information; requiring the Department to issue a certain public report by a certain
14 date each year that includes certain information; requiring the Department to adopt
15 certain regulations on or before a certain date; establishing certain civil and criminal
16 penalties; authorizing certain persons to bring a civil action under certain
17 circumstances; authorizing certain persons to apply to a certain court for permanent
18 or temporary injunctive relief against a certain person under certain circumstances;
19 providing for the award of certain attorney’s fees under certain circumstances;
20 requiring a court to make a certain determination in a certain proceeding; requiring
21 a court to issue certain orders under certain circumstances; requiring certain persons
22 to use a pseudonym to bring a certain action in court under certain circumstances;
23 providing for the construction of various provisions of this Act; stating certain
24 findings of the General Assembly; defining certain terms; and generally relating to
25 the Pain-Capable Unborn Child Protection Act.

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
7 That the Laws of Maryland read as follows:

8 **Article – Health – General**

9 **20–215. RESERVED.**

10 **20–216. RESERVED.**

11 **PART V. PAIN–CAPABLE UNBORN CHILD PROTECTION ACT.**

12 **20–217.**

13 **THE MARYLAND GENERAL ASSEMBLY FINDS THAT:**

14 **(1) PAIN RECEPTORS (NOCICEPTORS) ARE PRESENT THROUGHOUT**
15 **AN UNBORN CHILD’S ENTIRE BODY AND NERVES LINK THESE RECEPTORS TO THE**
16 **BRAIN’S THALAMUS AND SUBCORTICAL PLATE BY NO LATER THAN 20 WEEKS;**

17 **(2) BY 8 WEEKS AFTER FERTILIZATION, AN UNBORN CHILD REACTS**
18 **TO TOUCH AND, AFTER 20 WEEKS, AN UNBORN CHILD REACTS TO STIMULI THAT**
19 **WOULD BE RECOGNIZED AS PAINFUL IF APPLIED TO AN ADULT HUMAN;**

20 **(3) IN AN UNBORN CHILD, APPLICATION OF PAINFUL STIMULI IS**
21 **ASSOCIATED WITH SIGNIFICANT INCREASES IN STRESS HORMONES KNOWN AS THE**
22 **STRESS RESPONSE;**

23 **(4) SUBJECTION TO PAINFUL STIMULI IS ASSOCIATED WITH**
24 **LONG–TERM HARMFUL NEURODEVELOPMENTAL EFFECTS, INCLUDING ALTERED**
25 **PAIN SENSITIVITY AND, POSSIBLY, EMOTIONAL, BEHAVIORAL, AND LEARNING**
26 **DISABILITIES LATER IN LIFE;**

27 **(5) FOR THE PURPOSES OF SURGERY ON UNBORN CHILDREN, FETAL**
28 **ANESTHESIA IS ROUTINELY ADMINISTERED AND IS ASSOCIATED WITH A DECREASE**
29 **IN STRESS HORMONES COMPARED TO THEIR LEVEL WHEN PAINFUL STIMULI ARE**
30 **APPLIED WITHOUT FETAL ANESTHESIA;**

1 **(6) THE POSITION, ASSERTED BY SOME MEDICAL EXPERTS, THAT AN**
2 **UNBORN CHILD IS INCAPABLE OF EXPERIENCING PAIN UNTIL A POINT LATER IN**
3 **PREGNANCY THAN 20 WEEKS AFTER FERTILIZATION PREDOMINATELY RESTS ON**
4 **THE ASSUMPTION THAT THE ABILITY TO EXPERIENCE PAIN DEPENDS ON THE**
5 **CEREBRAL CORTEX AND REQUIRES NERVE CONNECTIONS BETWEEN THE THALAMUS**
6 **AND THE CORTEX, BUT RECENT MEDICAL RESEARCH AND ANALYSIS, ESPECIALLY**
7 **SINCE 2007, PROVIDE STRONG EVIDENCE FOR THE CONCLUSION THAT A**
8 **FUNCTIONING CORTEX IS NOT NECESSARY TO EXPERIENCE PAIN;**

9 **(7) SUBSTANTIAL EVIDENCE INDICATES THAT CHILDREN BORN**
10 **MISSING THE BULK OF THE CEREBRAL CORTEX, THOSE WITH HYDRANENCEPHALY,**
11 **NEVERTHELESS EXPERIENCE PAIN;**

12 **(8) IN ADULTS, STIMULATION OR ABLATION OF THE CEREBRAL**
13 **CORTEX DOES NOT ALTER PAIN PERCEPTION, WHILE STIMULATION OR ABLATION OF**
14 **THE THALAMUS DOES;**

15 **(9) SUBSTANTIAL EVIDENCE INDICATES THAT STRUCTURES USED**
16 **FOR PAIN PROCESSING IN EARLY DEVELOPMENT DIFFER FROM THOSE OF ADULTS,**
17 **USING DIFFERENT NEURAL ELEMENTS AVAILABLE AT SPECIFIC TIMES DURING**
18 **DEVELOPMENT, INCLUDING THE SUBCORTICAL PLATE, TO FULFILL THE ROLE OF**
19 **PAIN PROCESSING;**

20 **(10) THE POSITION, ASSERTED BY SOME MEDICAL EXPERTS, THAT AN**
21 **UNBORN CHILD REMAINS IN A COMA-LIKE SLEEP STATE THAT PRECLUDES AN**
22 **UNBORN CHILD EXPERIENCING PAIN IS INCONSISTENT WITH THE DOCUMENTED**
23 **REACTION OF UNBORN CHILDREN TO PAINFUL STIMULI AND WITH THE EXPERIENCE**
24 **OF FETAL SURGEONS WHO HAVE FOUND IT NECESSARY TO SEDATE AN UNBORN**
25 **CHILD WITH ANESTHESIA TO PREVENT THE UNBORN CHILD FROM THRASHING**
26 **ABOUT IN REACTION TO INVASIVE SURGERY;**

27 **(11) CONSEQUENTLY, THERE IS SUBSTANTIAL MEDICAL EVIDENCE**
28 **THAT AN UNBORN CHILD IS CAPABLE OF EXPERIENCING PAIN BY 20 WEEKS AFTER**
29 **FERTILIZATION;**

30 **(12) IT IS THE DUTY OF THE STATE TO ASSERT A COMPELLING STATE**
31 **INTEREST IN PROTECTING THE LIVES OF UNBORN CHILDREN FROM THE STAGE AT**
32 **WHICH SUBSTANTIAL MEDICAL EVIDENCE INDICATES THAT THEY ARE CAPABLE OF**
33 **FEELING PAIN; AND**

34 **(13) THE STATE'S COMPELLING INTEREST IN PROTECTING THE LIVES**
35 **OF UNBORN CHILDREN FROM THE STAGE AT WHICH SUBSTANTIAL MEDICAL**
36 **EVIDENCE INDICATES THAT THEY ARE CAPABLE OF FEELING PAIN IS INTENDED TO**
37 **BE SEPARATE FROM AND INDEPENDENT OF THE STATE'S COMPELLING INTEREST IN**

1 PROTECTING THE LIVES OF UNBORN CHILDREN FROM THE STAGE OF VIABILITY,
2 AND NEITHER STATE INTEREST IS INTENDED TO REPLACE THE OTHER.

4 (A) IN THIS PART THE FOLLOWING WORDS HAVE THE MEANINGS
5 INDICATED.

6 (B) (1) “ABORTION” MEANS THE INTENTIONAL USE OF ANY INSTRUMENT,
7 MEDICINE, DRUG, OR ANY OTHER SUBSTANCE OR DEVICE TO TERMINATE THE
8 PREGNANCY OF A WOMAN KNOWN TO BE PREGNANT.

9 (2) “ABORTION” DOES NOT INCLUDE THE INTENTIONAL
10 TERMINATION OF A PREGNANCY FOR THE PURPOSE OF:

11 (I) INCREASING THE PROBABILITY OF A LIVE BIRTH;

12 (II) PRESERVATION OF THE LIFE OR HEALTH OF THE CHILD
13 AFTER LIVE BIRTH; OR

14 (III) REMOVING A DEAD UNBORN CHILD WHO DIED IN UTERO AS
15 THE RESULT OF NATURAL CAUSES, ACCIDENTAL TRAUMA, OR A CRIMINAL ASSAULT
16 ON THE PREGNANT WOMAN OR HER UNBORN CHILD THAT CAUSES THE PREMATURE
17 TERMINATION OF A PREGNANCY.

18 (C) “ATTEMPT TO PERFORM OR INDUCE AN ABORTION” MEANS AN ACT, OR
19 AN OMISSION OF A STATUTORILY REQUIRED ACT, THAT, UNDER THE
20 CIRCUMSTANCES AS THE ACTOR BELIEVES THEM TO BE, CONSTITUTES A
21 SUBSTANTIAL STEP IN A COURSE OF CONDUCT PLANNED TO CULMINATE IN THE
22 PERFORMANCE OR INDUCTION OF AN ABORTION.

23 (D) “FERTILIZATION” MEANS THE FUSION OF A HUMAN SPERMATOZOON
24 WITH A HUMAN OVUM.

25 (E) (1) “MEDICAL EMERGENCY” MEANS A CONDITION THAT, IN
26 REASONABLE MEDICAL JUDGMENT, SO COMPLICATES THE MEDICAL CONDITION OF
27 THE PREGNANT WOMAN THAT IT NECESSITATES THE IMMEDIATE ABORTION OF HER
28 PREGNANCY WITHOUT FIRST DETERMINING POSTFERTILIZATION AGE TO AVERT
29 THE WOMAN’S DEATH OR FOR WHICH THE DELAY NECESSARY TO DETERMINE
30 POSTFERTILIZATION AGE WILL CREATE SERIOUS RISK OF SUBSTANTIAL AND
31 IRREVERSIBLE PHYSICAL IMPAIRMENT OF A MAJOR BODILY FUNCTION, NOT
32 INCLUDING PSYCHOLOGICAL OR EMOTIONAL CONDITIONS.

1 **(2) “MEDICAL EMERGENCY” DOES NOT INCLUDE A CONDITION BASED**
2 **ON A CLAIM OR DIAGNOSIS THAT THE WOMAN WILL ENGAGE IN CONDUCT THAT SHE**
3 **INTENDS TO RESULT IN HER DEATH OR IN SUBSTANTIAL AND IRREVERSIBLE**
4 **PHYSICAL IMPAIRMENT OF A MAJOR BODILY FUNCTION.**

5 **(F) “PHYSICIAN” MEANS ANY INDIVIDUAL LICENSED BY THE STATE BOARD**
6 **OF PHYSICIANS TO PRACTICE MEDICINE IN THE STATE.**

7 **(G) “POSTFERTILIZATION AGE” MEANS THE AGE OF THE UNBORN CHILD AS**
8 **CALCULATED FROM THE FUSION OF A HUMAN SPERMATOZOON WITH A HUMAN**
9 **OVUM.**

10 **(H) “PROBABLE POSTFERTILIZATION AGE OF THE UNBORN CHILD” MEANS**
11 **THE AGE THAT, IN REASONABLE MEDICAL JUDGMENT, WILL WITH REASONABLE**
12 **PROBABILITY BE THE POSTFERTILIZATION AGE OF THE UNBORN CHILD AT THE TIME**
13 **THE ABORTION IS PLANNED TO BE PERFORMED OR INDUCED.**

14 **(I) “REASONABLE MEDICAL JUDGMENT” MEANS A MEDICAL JUDGMENT**
15 **THAT WOULD BE MADE BY A REASONABLY PRUDENT PHYSICIAN WHO IS**
16 **KNOWLEDGEABLE ABOUT THE CASE AND THE TREATMENT POSSIBILITIES WITH**
17 **RESPECT TO THE MEDICAL CONDITIONS INVOLVED.**

18 **(J) “UNBORN CHILD” OR “FETUS” MEANS AN INDIVIDUAL ORGANISM OF**
19 **THE SPECIES HOMO SAPIENS FROM FERTILIZATION UNTIL LIVE BIRTH.**

20 **(K) “WOMAN” MEANS A FEMALE HUMAN BEING WHETHER OR NOT SHE HAS**
21 **REACHED THE AGE OF MAJORITY.**

23 **(A) (1) EXCEPT IN THE CASE OF A MEDICAL EMERGENCY, AN ABORTION**
24 **MAY NOT BE PERFORMED OR INDUCED OR BE ATTEMPTED TO BE PERFORMED OR**
25 **INDUCED UNLESS THE PHYSICIAN PERFORMING OR INDUCING THE ABORTION:**

26 **(I) HAS MADE A DETERMINATION OF THE PROBABLE**
27 **POSTFERTILIZATION AGE OF THE UNBORN CHILD; OR**

28 **(II) IS RELYING ON THE DETERMINATION OF THE PROBABLE**
29 **POSTFERTILIZATION AGE OF THE UNBORN CHILD MADE BY ANOTHER PHYSICIAN.**

30 **(2) IN MAKING A DETERMINATION UNDER PARAGRAPH (1) OF THIS**
31 **SUBSECTION, THE PHYSICIAN SHALL:**

32 **(I) MAKE INQUIRIES OF THE PREGNANT WOMAN; AND**

1 **(II) PERFORM OR CAUSE TO BE PERFORMED MEDICAL**
2 **EXAMINATIONS AND TESTS THAT A REASONABLY PRUDENT PHYSICIAN,**
3 **KNOWLEDGEABLE ABOUT THE CASE AND THE MEDICAL CONDITIONS INVOLVED,**
4 **WOULD CONSIDER NECESSARY TO PERFORM IN MAKING AN ACCURATE DIAGNOSIS**
5 **OF THE POSTFERTILIZATION AGE.**

6 **(B) THE FAILURE OF A PHYSICIAN TO CONFORM TO THE PROVISIONS OF**
7 **SUBSECTION (A) OF THIS SECTION IS DEEMED “UNPROFESSIONAL CONDUCT” UNDER**
8 **§ 14-404 OF THE HEALTH OCCUPATIONS ARTICLE.**

9 **20-220.**

10 **(A) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,**
11 **AN INDIVIDUAL MAY NOT PERFORM OR INDUCE OR ATTEMPT TO PERFORM OR**
12 **INDUCE AN ABORTION ON A PREGNANT WOMAN IF THE PROBABLE**
13 **POSTFERTILIZATION AGE OF THE WOMAN’S UNBORN CHILD HAS BEEN DETERMINED**
14 **BY A PHYSICIAN TO BE 20 WEEKS OR MORE.**

15 **(2) IF, IN THE REASONABLE MEDICAL JUDGMENT OF A PHYSICIAN,**
16 **THE PREGNANT WOMAN HAS A MEDICAL EMERGENCY, A PHYSICIAN MAY PERFORM**
17 **OR INDUCE AN ABORTION ON A PREGNANT WOMAN WHOSE UNBORN CHILD HAS A**
18 **PROBABLE POSTFERTILIZATION AGE OF 20 WEEKS OR MORE AS DETERMINED BY A**
19 **PHYSICIAN.**

20 **(B) (1) WHEN AN ABORTION IS PERFORMED OR INDUCED ON A PREGNANT**
21 **WOMAN UNDER SUBSECTION (A)(2) OF THIS SECTION, THE PHYSICIAN SHALL**
22 **TERMINATE THE PREGNANCY IN THE MANNER THAT, IN THE PHYSICIAN’S**
23 **REASONABLE MEDICAL JUDGMENT, PROVIDES THE BEST OPPORTUNITY FOR THE**
24 **UNBORN CHILD TO SURVIVE, UNLESS USING THAT METHOD WOULD, IN THE**
25 **PHYSICIAN’S REASONABLE MEDICAL JUDGMENT, POSE A GREATER RISK OF THE**
26 **DEATH OR OF THE SUBSTANTIAL AND IRREVERSIBLE PHYSICAL IMPAIRMENT OF A**
27 **MAJOR BODILY FUNCTION OF THE PREGNANT WOMAN, NOT INCLUDING**
28 **PSYCHOLOGICAL OR EMOTIONAL CONDITIONS.**

29 **(2) A MANNER OF ABORTION DOES NOT INCLUDE A GREATER RISK OF**
30 **DEATH OR SUBSTANTIAL AND IRREVERSIBLE PHYSICAL IMPAIRMENT OF A MAJOR**
31 **BODILY FUNCTION IF IT IS BASED ON A CLAIM OR DIAGNOSIS THAT THE WOMAN WILL**
32 **ENGAGE IN CONDUCT THAT SHE INTENDS TO RESULT IN HER DEATH OR IN**
33 **SUBSTANTIAL AND IRREVERSIBLE PHYSICAL IMPAIRMENT OF A MAJOR BODILY**
34 **FUNCTION.**

4 (1) THE POSTFERTILIZATION AGE OF THE UNBORN CHILD OF THE
5 PREGNANT WOMAN:

6 (I) IF A DETERMINATION OF PROBABLE POSTFERTILIZATION
7 AGE WAS MADE, WHETHER ULTRASOUND WAS EMPLOYED IN MAKING THE
8 DETERMINATION, AND THE WEEK OF PROBABLE POSTFERTILIZATION AGE
9 DETERMINED; AND

10 (II) IF A DETERMINATION OF PROBABLE POSTFERTILIZATION
11 AGE WAS NOT MADE, THE BASIS OF THE DETERMINATION THAT A MEDICAL
12 EMERGENCY EXISTED;

13 (2) THE METHOD OF ABORTION PERFORMED OR INDUCED,
14 INCLUDING:

15 (I) MEDICATION ABORTION, INCLUDING
16 MIFEPRISTONE/MISOPROSTOL, METHOTREXATE/MISOPROSTOL, OR ANY OTHER
17 MEDICATION USED;

18 (II) MANUAL VACUUM ASPIRATION;

19 (III) ELECTRICAL VACUUM ASPIRATION;

20 (IV) DILATION AND EVACUATION;

21 (V) COMBINED INDUCTION ABORTION AND DILATION AND
22 EVACUATION;

23 (VI) INDUCTION ABORTION WITH PROSTAGLANDINS;

24 (VII) INDUCTION ABORTION WITH INTRAAMNIOTIC
25 INSTILLATION, INCLUDING SALINE OR UREA;

26 (VIII) INDUCTION ABORTION;

1 **(3) WHETHER AN INTRAFETAL INJECTION WAS USED IN AN ATTEMPT**
2 **TO INDUCE FETAL DEMISE, INCLUDING THE USE OF INTRAFETAL POTASSIUM**
3 **CHLORIDE OR DIGOXIN;**

4 **(4) THE AGE AND RACE OF THE PREGNANT WOMAN; AND**

5 **(5) IF THE PROBABLE POSTFERTILIZATION AGE WAS DETERMINED TO**
6 **BE 20 OR MORE WEEKS:**

7 **(I) THE BASIS OF THE PHYSICIAN'S DETERMINATION THAT THE**
8 **PREGNANT WOMAN HAD A CONDITION THAT SO COMPLICATED HER MEDICAL**
9 **CONDITION AS TO NECESSITATE THE ABORTION OF HER PREGNANCY TO AVERT HER**
10 **DEATH OR TO AVERT SERIOUS RISK OF SUBSTANTIAL AND IRREVERSIBLE PHYSICAL**
11 **IMPAIRMENT OF A MAJOR BODILY FUNCTION, NOT INCLUDING PSYCHOLOGICAL OR**
12 **EMOTIONAL CONDITIONS; AND**

13 **(II) WHETHER OR NOT THE METHOD OF ABORTION USED WAS**
14 **ONE THAT, IN REASONABLE MEDICAL JUDGMENT, PROVIDED THE BEST**
15 **OPPORTUNITY FOR THE UNBORN CHILD TO SURVIVE AND, IF SUCH A METHOD WAS**
16 **NOT USED, THE BASIS OF THE DETERMINATION THAT TERMINATION OF THE**
17 **PREGNANCY IN THAT MANNER WOULD POSE A GREATER RISK OF THE DEATH OF THE**
18 **PREGNANT WOMAN OR OF THE SUBSTANTIAL AND IRREVERSIBLE PHYSICAL**
19 **IMPAIRMENT OF A MAJOR BODILY FUNCTION, NOT INCLUDING PSYCHOLOGICAL OR**
20 **EMOTIONAL CONDITIONS, OF THE WOMAN THAN OTHER AVAILABLE METHODS OF**
21 **ABORTION.**

22 **(B) (1) A REPORT REQUIRED UNDER SUBSECTION (A) OF THIS SECTION:**

23 **(I) MAY NOT INCLUDE:**

24 **1. THE NAME OR THE ADDRESS OF THE WOMAN WHOSE**
25 **PREGNANCY WAS TERMINATED; OR**

26 **2. ANY OTHER PERSONAL INFORMATION THAT COULD**
27 **IDENTIFY THE PREGNANT WOMAN; AND**

28 **(II) SHALL INCLUDE A UNIQUE MEDICAL RECORD IDENTIFYING**
29 **NUMBER TO ENABLE MATCHING THE PHYSICIAN'S REPORT TO THE INDIVIDUAL'S**
30 **MEDICAL RECORDS.**

31 **(2) A REPORT REQUIRED UNDER SUBSECTION (A) OF THIS SECTION**
32 **SHALL BE SUBMITTED ON THE FORMS AND ON A SCHEDULE REQUIRED BY THE**
33 **DEPARTMENT IN REGULATION.**

1 **(3) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**
2 **PARAGRAPH, A REPORT REQUIRED UNDER SUBSECTION (A) OF THIS SECTION SHALL**
3 **BE CONFIDENTIAL AND NOT AVAILABLE FOR PUBLIC INSPECTION.**

4 **(II) ON REQUEST, A REPORT REQUIRED UNDER SUBSECTION (A)**
5 **OF THIS SECTION SHALL BE MADE AVAILABLE:**

6 **1. TO THE ATTORNEY GENERAL OR A STATE'S**
7 **ATTORNEY PURSUANT TO A CRIMINAL OR CIVIL INVESTIGATION; OR**

8 **2. ON A COURT ORDER.**

9 **(C) (1) ON OR BEFORE JUNE 30 OF EACH YEAR, THE DEPARTMENT SHALL**
10 **ISSUE A PUBLIC REPORT PROVIDING STATISTICS FOR THE PREVIOUS CALENDAR**
11 **YEAR COMPILED FROM ALL OF THE REPORTS COVERING THAT YEAR SUBMITTED IN**
