Anne Arundel County – Alcoholic Beverages – Licenses

- 3 FOR the purpose of authorizing in Anne Arundel County a holder of a certain <u>Class BLX</u> 4 license to be issued a music permit, an entertainment permit, an outdoor permit, or $\mathbf{5}$ an outdoor entertainment permit; authorizing a holder of a certain Class BLX license 6 to be issued a dancing permit, except under certain circumstances; exempting certain 7 alcoholic beverages licenses in the county from a prohibition against issuing multiple 8 licenses to any one person; exempting a certain class of license from a prohibition 9 against issuing an alcoholic beverages license for a location within a certain distance 10 from a place of worship or school; allowing a license holder to be issued a second or 11 third alcoholic beverages license of a certain type for a restaurant if the restaurant 12 is located in a shopping center that has a certain zoning classification; and generally 13relating to alcoholic beverages licenses in Anne Arundel County.
