1 AN ACT concerning

2 **Vehicle Laws – Electric Personal Assistive Mobility Device – Definition**

3 FOR the purpose of altering the definition of “electric personal assistive mobility device” to
4 require that the device have a certain steering mechanism and a certain platform on
5 which the rider stands; and generally relating to electric personal assistive mobility
6 devices.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Transportation**

20 21–101.

1 (a) In this title and Title 25 of this article the following words have the meanings
2 indicated.

3 (j) “Electric personal assistive mobility device” or “EPAMD” means a pedestrian
4 device that:

5 (1) Has two nontandem wheels;

6 (2) Is self-balancing;

7 (3) Is powered by an electric propulsion system;

8 (4) **HAS ONE VERTICAL OR CENTER CONTROL BAR OR MECHANISM**
9 **THAT RESPONDS TO PRESSURE FROM THE HANDS OR LEGS OF THE RIDER TO STEER**
10 **THE DEVICE;**

11 (5) **HAS A NONARTICULATING PLATFORM ON WHICH THE RIDER**
12 **STANDS;**

13 [(4)] (6) Has a maximum speed capability of 15 miles per hour; and

14 [(5)] (7) Is designed to transport one person.

16 (a) At an intersection, a person using an EPAMD is subject to all traffic control
17 signals, as provided in §§ 21-202 and 21-203 of this title. However, at any other place, a
18 person using an EPAMD has the rights and is subject to the restrictions applicable to
19 pedestrians under this title.

20 21-1201.

21 (c) With the exceptions stated in this subtitle, the provisions of this subtitle that
22 are applicable to bicycles apply whenever a bicycle, an EPAMD, or a motor scooter is
23 operated on any highway or whenever a bicycle or an EPAMD is operated on any path set
24 aside for the exclusive use of bicycles.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2016.
