Alcoholic Beverages - Multiple Manufacturer's Licenses - Sampling, Sale, and Consumption of Products

- 4 FOR the purpose of repealing certain provisions of law that prohibit certain holders of $\mathbf{5}$ certain alcoholic beverage manufacturer's licenses from selling or allowing to be 6 consumed at certain locations certain products; authorizing the holder of a farm 7 brewery license to apply for and obtain, under a different name, additional licenses for the same or different premises; authorizing the holder of multiple manufacturer's 8 9 licenses to allow the sampling, sale, and consumption of certain products at certain 10 locations, subject to a certain restriction; and generally relating to authority for 11 holders of certain alcoholic beverage manufacturer's licenses to allow the sampling, 12 sale, and consumption of certain products.
