2 Marijuana – Smoking or Consuming in a Vehicle or Vessel – Prohibition

- 3 FOR the purpose of prohibiting a person from smoking or otherwise consuming marijuana 4 while operating or attempting to operate a vessel; prohibiting a driver of a motor 5 vehicle from smoking or otherwise consuming marijuana in the motor vehicle on a 6 highway; prohibiting a passenger of a motor vehicle on a highway from smoking 7 marijuana in a passenger area of a motor vehicle or consuming marijuana in an area 8 of a motor vehicle that is readily accessible to the driver of the motor vehicle; 9 establishing certain penalties; defining certain terms; and generally relating to 10 smoking or consuming marijuana.

- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 22 That the Laws of Maryland read as follows:

- 1 (A) A PERSON MAY NOT SMOKE OR OTHERWISE CONSUME MARIJUANA 2 WHILE OPERATING OR ATTEMPTING TO OPERATE A VESSEL.
- 3 (B) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR 4 AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$500.

- 7 (A) (1) IN THIS SECTION, "PASSENGER AREA" MEANS AN AREA THAT IS 8 DESIGNED TO SEAT THE DRIVER AND ANY PASSENGER OF A MOTOR VEHICLE WHILE
- 9 THE MOTOR VEHICLE IS IN OPERATION.
- 10 (2) "PASSENGER AREA" DOES NOT INCLUDE:
- 11 (I) A LOCKED GLOVE COMPARTMENT; OR
- 12 (II) THE TRUNK OF A MOTOR VEHICLE.
- 13 (B) THIS SECTION APPLIES TO A MOTOR VEHICLE THAT IS DRIVEN, STOPPED, STANDING, OR OTHERWISE LOCATED ON A HIGHWAY.
- 15 (C) A DRIVER OF A MOTOR VEHICLE MAY NOT SMOKE OR OTHERWISE
- 16 CONSUME MARIJUANA IN A PASSENGER AREA OF THE MOTOR VEHICLE ON A
- 17 HIGHWAY.
- 18 (D) A PASSENGER OF A MOTOR VEHICLE ON A HIGHWAY MAY NOT:
- 19 (1) SMOKE MARIJUANA IN A PASSENGER AREA OF THE MOTOR
- 20 VEHICLE; OR
- 21 (2) CONSUME MARIJUANA IN AN AREA OF THE MOTOR VEHICLE THAT
- 22 IS READILY ACCESSIBLE TO THE DRIVER OF THE MOTOR VEHICLE WHILE IN A
- 23 SEATED POSITION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
