A BILL ENTITLED

1 AN ACT concerning

2 Cecil County - Orphans' Court Judges - Traveling Expense Allowance and 3 Pension

4 FOR the purpose of specifying that the annual compensation of the judges of the Orphans' $\mathbf{5}$ Court for Cecil County for certain fiscal years is to be paid quarterly by the county; 6 increasing the allowance for traveling expenses for the judges of the Orphans' Court 7 for Cecil County; specifying that the allowance is to be paid by the county; requiring 8 the county to pay a pension to certain former judges of the Orphans' Court for Cecil 9 County; providing that a judge of the Orphans' Court for Cecil County who has completed a certain number of years of service is eligible for a pension; providing for 10 11 the application of this Act; and generally relating to traveling expense allowances and 12pensions for judges of the Orphans' Court for Cecil County.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 19 That the Laws of Maryland read as follows:

(a) (1) Except in Montgomery County and Harford County, the judges of the
 courts shall receive compensation and allowances as prescribed by law.

1 (2) Unless otherwise provided, the compensation shall be paid in monthly $\mathbf{2}$ installments. 3 Mileage or travel expenses may not be allowed to a judge for attending (3) 4 sessions of his court except as specifically provided. $\mathbf{5}$ Each of the judges of the Court for Cecil County shall receive an annual (i) (1)6 compensation of: 7 (i) \$5,500 for fiscal year 2015; 8 (ii) \$6,500 for fiscal year 2016; 9 (iii) \$7,500 for fiscal year 2017; and 10 \$8,750 for fiscal year 2018 and each subsequent fiscal year, TO (iv) 11 BE PAID QUARTERLY BY THE COUNTY. 12(2)Each judge shall also receive an allowance for traveling expenses of 13[\$780] **\$1,600** annually, to be paid quarterly by the [County Commissioners] COUNTY. SECTION 2. 1 An annual amount calculated at the rate of 4 percent of the last (ii) $\mathbf{2}$ annual amount of compensation multiplied by the number of years or partial years of 3 service, not exceeding 12 years. 4 (3)An Orphans' Court judge in Somerset County and Worcester County is eligible for a pension under this subsection only if he is in office on or before July 1, 1979. $\mathbf{5}$ 6 (4) In Wicomico County AND CECIL COUNTY, an Orphans' Court judge 7 who has completed at least 12 years in office is eligible for a pension under this subsection. 8 (5)In Prince George's County, the salary or pension to each Orphans' Court 9 judge shall be the greater of: 10 \$1,200 annually; or (i) 11 An annual amount calculated at the rate of 4 percent of the last (ii) 12annual amount of compensation multiplied by the number of years or partial years of 13service, not exceeding 20 years. 14(6)In Allegany County, the pension for an Orphans' Court judge shall be 15the greater of: 16(i) \$1,200 annually; or 17Except as provided in item 2 of this subparagraph, an (ii) 1. 18annual amount calculated at the rate of 4 percent of the last annual amount of 19compensation multiplied by the number of years of service, not exceeding 16 years; or 20An annual amount equal to two-thirds of the last annual 2. 21amount of compensation if the judge has more than 16 years of service. 22(7)The pension or salary may be suspended during any month the judge is 23a full-time employee of any county or of this State. 24Notwithstanding any provision of this section an Orphans' Court judge (8)25may not receive a pension under this section if he is receiving any other State pension based 26on service as an Orphans' Court judge. 27SECTION 3. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35 of the Maryland Constitution, Section 1 of this Act may not be construed to extend or apply 2829to the salary or compensation of a judge of the Orphans' Court for Cecil County while serving 30 in a term of office beginning before the effective date of this Act, but the provisions of this Act concerning the salary or compensation of the judges of the Orphans' Court for Cecil 3132County shall take effect at the beginning of the next following term of office. This limitation 33 does not apply to an individual appointed or elected after the effective date of this Act to 34fill out an unexpired term.

1 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall be construed to 2 apply retroactively and shall be applied to and interpreted to affect any individual who, on 3 or after July 1, 2014, was serving as an elected or appointed judge of the Orphans' Court for 4 Cecil County.

5 SECTION 5. AND BE IT FURTHER ENACTED, That, except as provided in 6 Sections 3 and 4 of this Act, this Act shall take effect July 1, 2016.
